- (b) County Road #351- Sinclair-Seminole Dam, approximately 25 miles beginning in the SW corner Sec. 16, Twp. 21N., R 86W ending in center Sec. 14, Twp. 24N, R 85 W.
2. Bituminous surfacing, sealing and miscellaneous work.

McFADDEN-ARLINGTON ROAD

The following route was suggested for the McFadden-Arlington Road, beginning at a point about 3/4 mile north of Arlington interchange on County road in W $\frac{1}{2}$ Sec. 19, thence in northeasterly direction to a point on North line of Sec. 19, approximately 600 Ft. West of NE corner Sec. 19, thence continuing in northeasterly direction diagonally across Sec. 17 to a point approximately 300 Ft. south of NE corner of Sec. 17, thence on curve to the right to a point on North line Sec. 16, then following section line between sections 9 and 16, approximately 4000 Ft., thence on a curve to left to a point approximately 1600 Ft. N. of SW $\frac{1}{4}$ Sec. 10, thence on a curve to right to a point approximately 900 Ft. E of W $\frac{1}{4}$ quarter corner of Sec. 10., thence east along East West center line of Sec. 10 a distance of approximately 2500 Ft., thence on a curve to left to a point on E. line of Sec. 10, approximately 1300 Ft. N of E quarter corner of Sec. 10, thence north along east line of Sec. 10 a distance of 1300 Ft. more or less to NE corner of Sec. 10, thence N along line between Sec. 2 and 3 to E quarter corner of Sec. 3, thence northeasterly to the southwest boundary of McFadden Townsite, Twp. 19, Range 78W.
