A motion was made by Orton, seconded by McMillen and carried whereby the following resolution was adopted, to wit:

OLD PROJECT FAP 59-A-R-I, MEDICINE BOW-RAWLINS ROAD:

R E S O L U T I O N

WHEREAS, the Board of County Commissioners of Carbon County, Wyoming, deem that a portion of old Project FAP 59-A-R-I, The Medicine Bow-Rawlins Road, described as follows:

Beginning at a point in the SW $\frac{1}{4}$ NW $\frac{1}{4}$  of Section 4, T. 22 N., R. 80 W. on the westerly boundary of the new right of way as same is described in an Agreement between the Union Pacific Railroad Company and the State of Wyoming, said agreement being dated December 20, 1948, which point of beginning is north 3350 feet and west 1455 feet from the southwest corner of said Section 4; thence in a westerly direction following the alignment alignment of old Project FAP 59-A-R-I for a distance of 6.943 miles, more or less, across Sections 4,5 and 6 of T.22 N., R. 80W., Sections 1, 12, 11, 14, 15 and 16 of T.22 N., R.81W., all of the 6th P.M., Carbon County, Wyoming, to a point of ending on the East Corporate Limits of the Town of Elmo, said point of ending being located in Section 16 of said township and range and being north 121 feet from the southeast corner of the SW $\frac{1}{4}$ NW $\frac{1}{4}$  of said section 16; being no longer used or necessary for State Highway purposes, would, in the best interest of the public, be a necessary and desirable extension of the Carbon County Road System.

NOW, THEREFORE BE IT RESOLVED, that the said Board do hereby declare that Carbon County will assume all responsibility with regard to repair, service and maintenance of the above described portion of the old Medicine Bow-Rawlins road upon relinquishment by the State Highway Commission of Wyoming to Carbon County.

adopted, to wit:

R E S O L U T I O N

RIVERSIDE-SOUTHWEST ROAD, PROJECT S-0401 (6)

WHEREAS, The Board of County Commissioners of Carbon Count, Wyoming, deem the public interest requires that a road be established to be known as Riverside-Southwest Road, Project S-0401 (6), described as follows:

Commencing at a point on the west boundary of Section 18, T.14N., R.84W. from the northwest corner of Lot 4 of said section 18 bears northerly a distance of 670 feet, more or less;

Thence in a northeasterly direction for a distance of approximately 7.1 miles across Sections 18,17, 16,9,10, 3,2,11 and all of T. 14 N., R. 84 W. of the 6th P.M., Wyoming, to a point on the north corporate limits of the Town of Riverside.

NOW, THEREFORE, BE IT RESOLVED, That the said Board do hereby initiate the procedure for the establishment of said road, and declare their intention to establish said road by following out the provisions of Section 24-43, Wyoming Statutes, 1957, not inconsistent therewith.
