HEALTH NURSE: The Board received a letter of resignation of Miss Ann Shepard, County Health Nurse, effective Oct. 15, 1971. The Board accepted this resignation, the State Board of Health will recommend a new appointment.

PLATS OF THE

OLSON ADDITION TO RAWLINS AND VETERAN'S ADDITION TO TOWN OF HANNA were presented to the Board of consideration.

Addition to Hanna, Wyo. be accepted as presented and the plats placed on record.

RIVERSIDE-SOUTHWEST ROAD, PROJECT S-0401 (6)

On July 6, 1971 the Board of Commissioners adopted a resolution and declared their intention to establish said road by following the procedure for establishment in compliance with Section 24-43, W. C. S. 1957 not inconsistent therewith. On Sept. 8, 1971, the Board appointed three appraisers to view the proposed road and establish a true value of the property taken from Norman W. and Delores Sjogren of 12244-76th South, Seattle, Wash. 98178. The appraisers are as follows, Hoyt Parkison, Robert Hammer and Ronald Wolfard, all of Encampment, Wyo.

The appraisers made their inspection on Sept. 24, 1971 at noon. A letter notifying Norman W and Delores Sjogren was mailed to them by the Appraisers in which they were notified of the time of their inspection and appraisal and the amount of damages fixed, which they reported to the Commissioners to be \$750.00.
