Nov. 3, 1971. The Board resumed its session, all members present, John Niland Chairman.

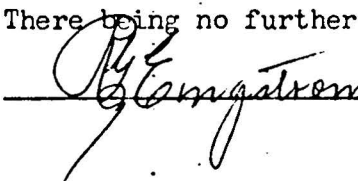
DEPUTY COUNTY TREASURER: The Board approved the appointment of Carolyn Gettman, Deputy County Treasurer.

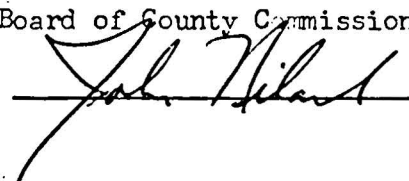
Carbon County Public Health Nursing Advisory Committee, The Board approved the appointment of D. W. Aylsworth, D.D.S as a new member.
