

After consideration of other business to come before the Board, on motion, the meeting was adjourned.



COUNTY DEPOSITORIES - 1971 The following County depositories were designated for the year 1971.

The First National Bank-Rawlins, Rawlins National Bank-Rawlins, Rawlins Federal Savings & Loan Association of Rawlins, and the Saratoga State Bank of Saratoga, Wyo.

OFFICIAL NEWSPAPER: The Rawlins Daily Times was designated as the official publication for the 1971 and 1972 calendar years.

WELFARE BOARD: Commissioner John Orton was appointed as a member of the Carbon County Welfare Board for a two year term, expiring Jan. 1, 1973.

Thereupon the Board adjourned until the following day.

Jan. 6, 1971. The resumed its session, all members present, Miland Chairman.

TRANSFER OF FUNDS FROM CASH RESERVE: In compliance with Art.3, Sec. 9-535 of Municipal Budget Act., Wyo. Statutes of 1957, a Notice of Hearing on the proposed transfer of funds from the Cash Reserve Fund was advertised on Dec. 9, 1970 and another notice was published on Dec. 29, 1970, as follows:

Elections \$5000.00 and General Welfare Fund \$46,775.80. A motion was made by Orton and carried whereby the following resolution was adopted, to wit:

RESOLUTION.

WHEREAS, the above budgets have become depleted due to unanticipated costs of primary, general and special elections, and,

WHEREAS, THE legal levy of 1.7 mills in the current County Welfare budget within the 12 mill County levy, was made and is deficient by .8 of a mill; and

WHEREAS, said deficiency in the amount of \$46,775.80 must be placed in said welfare budget in order to qualify for matching State and Federal funds; and

WHEREAS, said sum of \$46,775.80 must be transferred from the cash reserve fund to the Welfare fund; and

WHEREAS, legal publication of notice of said intended transfer has been made in the Rawlins Daily Times and a copy of same forwarded to the State Examiner, State of Wyoming; and

WHEREAS, NO PERSON APPEARED TO ENTER OBJECTION TO SAID TRANSFER.

NOW THEREFORE, be it resolved that the sum of \$46,775.80 be, and the same is hereby transferred from the cash reserve fund to the Welfare fund. The Commissioners decided to supplement the Election in the amount of \$2000 instead of \$5000, as the Hospital will pay the election costs in the amount of \$2844.83.

LIQUOR LICENSE: The Commissioners approved the transfer of Liquor License No. 161 that was issued to Robert D. Jackson and Matilda Warburton of Hanna, Wyo. on Oct. 7, 1970, to Cowboy Development Corporation of Shirley Basin, Wyo. The above owners of Home Ranch Bar & Lounge advised the Commissioners that they have sold this license to Cowboy Development Corporation, no protests were entered in the transfer of the license, which expires Oct. 7, 1971.

DEPUTY COUNTY CORONERS: A letter of resignation as Deputy County Coroners, was received from Lary L. Shriner and George M. Shriner. These resignations were accepted, no further action was taken.

STATE EXAMINERS REPORT of Carbon County offices for the period August 20, 1969 to October 26, 1970 was received and examined by the Board. The suggestions of the Examiner will be corrected by the Board.

There being no further business, the meeting was adjourned.
