A special meeting of the Board of County Commissioners of the County of Carbon, State of Wyoming, was held at the County Courthouse in Rawlins, Wyoming, on Monday, the 15th day of March, 1971, at the hour of 2:00 o'clock P. M.

The Chairman of the Board called the meeting to order and upon roll call the following were present:

The Clerk stated that all bids for the purchase of General Obligation Hospital bonds of the County in the principal amount of \$335,000 which were received prior to 2:00 o'clock P.M., on March 15, 1971, have been opened and tabulated. After consideration of the bids submitted, it appeared that the bid of The First National Bank of Rawlins, and, of Wyoming National Bank of Casper, Wyoming, was the highest and best bid submitted for the purchase of said bonds, such bid having a net effective interest rate of 3.547468%.

Thereupon Commissioner Orton introduced and there was read the following Resolution:

## R E S O L U T I O N

WHEREAS, all bids for the purchase of General Obligation Hospital Bonds of the County of Carbon, Wyoming, in the principal amount of \$335,000, which were received prior to 2:00 o'clock P. M., M.S.T., have been opened and tabulated; and

WHEREAS, it appears that the bid of The First National Bank of Rawlins, and Wyoming National Bank of Casper, Wyoming, is the highest and best bid for said bonds, and that it is in the best interest of the County that such bid be accepted;

THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF CARBON COUNTY, WYOMING:

Section 1 That the bid of The First National Bank of Rawlins and Wyoming National Bank of Casper, Wyoming, for the purchase of \$335,000 General Obligation Hospital Bonds of Carbon County, Wyoming, be and the same is hereby accepted, and the bonds are hereby awarded to said bidder.

Section 2. That the good faith deposit submitted by the successful bidder be credited to the purchaser upon delivery of the bonds.

The Chairman declared that all members of the Board of County Commissioners had voted in favor of said Resolution and that the motion was carried and the Resolution was dully adopted.

Thereupon Commissioner Orton introduced the following Resolution, which was read in full and is as follows:

R E S O L U T I O N

WHEREAS, the Board of County Commissioners of Carbon County had previously determined that the estimated cost of completing the construction of the Memorial Hospital in Rawlins was the amount of \$335,000, and that it was necessary to submit to the qualified electors of Carbon County, the question of issuing general obligation bonds for such purpose; and

WHEREAS, the qualified electors of Carbon County, Wyoming, at a special bond election held in the County on Tuesday, the 29th day of December, 1970, approved the issuance of general obligation bonds of the County in the principal amount of \$335,000, for the purpose of completing the construction and equipping of the County Memorial Hospital in Rawlins, Wyoming; and

WHEREAS, notice of sale of said bonds has been published in the time and manner required by law, and the Board of County Commissioners has awarded said bonds to The First National Bank of Rawlins and Wyoming National Bank of Casper, Wyoming, the highest and best bidder therefor; and

WHEREAS, the Board of County Commissioners has determined to authorize the issuance of the bonds so approved at the election on December 29, 1970;

THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF CARBON COUNTY, WYOMING:

Section 1. That general obligation negotiable coupon bonds of the County of Carbon, Wyoming, in the principal amount of \$335,000, each to be designated "General Obligation Hospital Bonds Series April 1, 1971", shall be issued for the purpose of completing the construction and equipping of the County Memorial Hospital in Rawlins, Wyoming.

Section 2. That said Bonds shall be dated as of April, 1, 1971, shall consist of 335 bonds in the denomination of \$1,000 each,

numbered 1 to 335, inclusive, shall bear interest payable on April 1, 1972, and semi-annually thereafter on April 1 and October 1 each year, and mature serially on April 1, as follows:

Bonds of this issue are not redeemable prior to their respective maturity dates.

The principal of and interest on said bonds will be payable at the office of the County Treasurer of Carbon County, in Rawlins, Wyoming.

Said bonds shall be signed by the manual signature of the Chairman of the Board of County Commissioners, sealed with a facsimile of the seal of said County and attested with the facsimile signature of the County Clerk. The interest accruing on said bonds shall be evidenced by interest coupons attached thereto, bearing the facsimile signature of the Treasurer of said County, and when so executed, such interest coupons shall be the bidding obligations of the County according to their import. In addition, the Clerk shall endorse a certificate upon each bond, that the same is within the lawful debt limit of the County, and is issued according to law. Should any officer whose manual or facsimile signature appears on said bonds, interest coupons or certificate, cease to be such officer before delivery of the bonds to the purchaser, such manual or facsimile signature shall nevertheless be valid and sufficient for all purposes.

Section 3. Said bonds and the interest coupons to be attached thereto and the registration certificate to appear thereon shall be in substantially the following form:

This Bond is issued by the Board of County Commissioners of Carbon County, Wyoming, for the purpose of completing the construction and equipping of the County Memorial Hospital in Rawlins, Wyoming, under the authority of and in full conformity with Title 18, Chapters 5 and 9, Wyoming Statutes, 1957, as amended, and all other laws thereunto enabling.

It is hereby certified, recited and warranted that all acts, matters and things required to occur, be done and performed legally to issue this Bond, have duly occurred, happened, been done

and performed; that the total indebtedness of the County, including that of this Bond, does not exceed any limit of indebtedness prescribed by the Constitution or Laws of the State of Wyoming; that the issuance of this Bond was authorized by the qualified electors of the County at an election duly called and held prior to the issuance hereof; and that provision has been made for the levy and collection of an annual tax on all the taxable property in the County sufficient to pay the interest on and principal of this Bond when the same become due.

The Full faith and credit of the County are hereby pledged for the punctual payment of the principal of and the interest on this Bond.

Section 4. That said bonds, when so executed, shall be delivered to the purchaser thereof, upon receipt of the purchase price therefor, solely to provide the County with money for the purpose hereinbefore specified. The proceeds of the bonds shall be used only for the purpose of completing the construction and equipping of the County Memorial Hospital in Rawlins, and for no other purpose whatever. Neither the purchaser nor any subsequent holder of any of said bonds shall be responsible for the application or disposal of the proceeds of said bonds by the County, or any of its officers.

The proceeds of the bonds herein authorized shall be used only for the purposes recited above; provided, however, that any portion of the bond proceeds may be temporarily invested pending such use in securities or obligations which are lawful investments for counties in the State of Wyoming. The temporary investment of the bond proceeds, or any portion thereof, shall be of such nature and extent, and for such period, that the bonds of the County shall not be or become arbitrage bonds within the meaning of Section 103(d) of the Internal Revenue Code, and pertinent regulations, and such proceeds, if so invested, shall be subject to the limitations and restrictions of said Section 103(d) (4), as the same now exists or may later be amended, and shall further be subject to any applicable regulations of the Internal Revenue Service.

Section 5. That the County Clerk shall endorse on each of said bonds the certificate required by Section 8 of Article XVI of the Constitution and Section 18-139, Wyoming Statutes, 1957, and shall sign such certificate in his official character. In addition, the Treasurer of the County shall keep a book in which shall be registered all such bonds so issued, showing the number, date of issue, to whom issued, amount of bond, date of redemption and payment of interest and principal.

Section 6. For the purpose of paying the principal of and interest on said bonds as the same shall become due, there shall be levied on all of the taxable property in the County, in addition to all other taxes, direct annual taxes in each of the years 1971 to 1980, inclusive, sufficient to pay such interest and principal promptly as the same become due and payable respectively.

Said taxes shall be computed and ascertained on the assessment and tax rolls and collected by the same officers and in the same manner as other taxes of the County and shall be used for the payment of interest and principal of the bonds herein authorized, and for no other purpose. Said taxes are hereby appropriated for that purpose, and the amount for each year shall be included in the annual appropriation bill and budget passes and adopted by the Board of County Commissioners in each of said years. The Board shall do all acts and things necessary fully to carry out the provisions of this Section.

Section 7. It shall be the duty of the Board of County Commissioners of said County, annually, at the time and in the manner provided by law for levying other County taxes, if such action shall be necessary to effectuate the provisions of this Resolution, to ratify and carry out the provisions herein with reference to the levy and collection of taxes. The Board of County Commissioners shall require the officers of and for said County to levy, extend and collect such taxes in the manner provided by law for the purpose of creating a fund for the payment of the interest on and principal of said bonds, as hereinabove specified. Nothing contained in this Resolution shall prevent the use of any other funds available therefor in the payment of the principal of or interest on said bonds and upon any such payment the levies

herein provided shall be reduced accordingly. In the event any of said tax levies do not produce a sufficient amount to pay the annual interest on and the specified amount of principal of said bonds, the deficiency shall be made up from the general fund of the County and included in the next succeeding tax levy.

Section 8. After said bonds have been issued, this Resolution shall be irrevocable until both the principal of and interest on said bonds shall be fully paid, satisfied and discharged.

Section 9. All resolutions of parts thereof in conflict with this Resolution are hereby repealed.

Section 10. That if any one or more sections or parts of this Resolution shall be adjudged unenforceable or invalid, such judgment shall not affect, impair or invalidate the remaining provisions of this Resolution, it being the intention that the various provisions hereof are severable.

Section 11. This Resolution, after its final passage and approval, shall be recorded by the Clerk in a book kept for that purpose, and shall be published in accordance to law.




