PROJECT AGREEMENT COOPERATIVE RECONSTRUCTION OF DEEP CREEK ROAD #801, U.S. DEPARTMENT OF AGRICULTURE FOREST SERVICE.

The Board of Commissioners entered into a project agreement between the Forest Service, U.S. Department of Agriculture, for reconstruction of the above mentioned road and is on file in the office of the County Clerk.

ELECTION DISTRICTS AND POLLING PRECINCTS. In compliance with Article 4, sections 22-118-65 and 22-118-66, the Board of Commissioners established the voting districts and precincts as follows; the Board decided to remove the voting machines from Encampment and Snake River. Collins and Riverside were consolidated and will be known as District 12, Precinct 2. Encampment will be known as District 12, Precinct 1. Severy and Dixon were consolidated and will be known as District 14, Precinct 1, and Baggs will be known as District 15, Precinct 1, making a total of 22 election precincts. Paper ballots will be used in all precincts that do not have voting machines.

#### DISTRICT 1- RAWLINS

All that area encompasses by the following closed perimeter description shall be known as ELECTION DISTRICT No. 1:

Beginning at a point which is the intersection of the UPRR and Tenth Street; thence Northerly along 10th Street, including the Chrisman Block, to an intersection with Buffalo Street; thence easterly along Buffalo Street and the projection thereof to an intersection with the projected South line of Sawtell's First Addition; thence east along said Sawtell's Addition south boundary and the projection thereof to an intersection of the east city limits; thence south along the east city limits to the south city limits; thence west to the west city limits; thence north along west city limits to an intersection with the UPRR; thence easterly along the UPRR to the original point of beginning.

#### DISTRICT 2- RAWLINS

Beginning at the NE corner of Sec. 4, Tp. 24 N, R. 87W, running thence west along the Tp. line between Tps. 24 and 25, and to the NW. corner of Tp. 24N., R. 89W; thence south along the west boundary line of Carbon County to the southwest corner of Sec. 35, Tp. 20 N.R. 90W thence west on Tp. line between Tps. 19 and 20 to the range line between ranges 90 and 91; thence south on range line between range 90 and 91 to the southwest corner of Tp. 16N.R.90W; thence east on the Tp. line between Tp. 15 and 16 to the line between ranges 87 and 88W; thence north on the range line between ranges 87 and 88 to the southwest corner of Tp. 18N., R. 87W; thence east on the Tp. line between Tp. 17 and 18 to the southeast corner of Tp. 18N., R. 86W; thence north on range line between ranges 85 and 86 to the Tp. line between Tps. 18 and 19; thence east on the township line between Tps. 18 and 19 to the range line between ranges 84 and 85; thence north on range line between ranges 84 and 85 to Tp. line between Tps. 19 and 20; thence west on township line between to Tps. 19 and 20 to the range line between ranges 85 and 86; thence north on range line between ranges 85 and 86 to the northeast corner of Tps. 20N R. 86W; thence west on township line between Tps. 20 and 21 to the southeast corner of Tps. 21N., R 87W; thence north on range line between ranges 86 and 87 to the Tp. line between Tps. 21 and 22; thence west on the Tps. line between Tps. 21 and 22 to the southeast corner of Sec. 33 Tp., 22N. R.87W; thence north to th place of beginning, NE corner Sec. 4, Tp. 24N. R. 87W.

#### DISTRICT 3 - RAWLINS

All that area encompassed by the following closed perimeter description shall be known as ELECTION DISTRICT NO. #3:

Beginning at a point which is the intersection of Buffalo Street and Seventh Streets; thence northerly along Seventh Street and the projection thereof to an intersection with the north city limits; thence west along said city limits to an intersection with the west city limits; thence south along said west city limits to an intersection with the UPRR, to an intersection with Tenth Street; thence northerly, excluding the Chrisman Block, to an intersection with Buffalo Street; thence easterly along Buffalo Street to the original point of beginning.

#### DISTRICT 4 - LAMONT

Beginning at a point on the West line of Carbon County which is the S.W. corner of T. 25N R., 89W.; thence E. along the S. line of T. 25N. to the S.E. Corner of T. 25N.R. 85; thence north along township line between ranges 84 and 85 to the PatheFinder Reservoir following west line of the PatheFinder Reservoir to north line of Carbon County; thence west to N.W. corner of T. 28 R. 89; thence south along County line or point of beginning.

#### DISTRICT 5 - SEMINOE DAM

Beginning at the S. W. corner of T. 25 R. 84W, thence east to the west bank of the Seminoe Reservoir following the west bank of the Seminoe Reservoir and the North Platte River and the Pathe Finder Reservoir to its intersection of the west line of R. 84, thence S. along range line between ranges 84 and 85 to the point of beginning.

#### DISTRICT 6 - LEO

All that area encompassed by the following closed perimeter description shall be known as ELECTION DISTRICT NO. 6:

Beginning at a point which is the S. E. corner of T. 25N., R. 80W; thence N. to the N. E. corner of said T. & R.; thence W. to the N. W. corner of said T. & R; thence North to the N. W. corner T. 26N., R. 80W.; thence E. to the E. Line of Carbon County; thence N to the N. line of Carbon County; thence W. to

original channel of the North Platte River; thence S. along said river channel to the S. line T. 25N., R. 84W.; thence E. to the N.W. corner T. 24N., R. 83W.; thence S. to the S.W. of said T. & R.; thence E. to the S.E. corner of T. 24N., R. 82W.; thence N. to the N.E. of said T. & R.; thence E. to the original point of beginning.

DISTRICT NO. 7 - MEDICINE BOW

All that area encompassed by the following closed perimeter description shall be known as ELECTION DISTRICT NO. 7:

Beginning at a point which is intersection of E. line of Carbon County and the S. line of T. 22N.; thence N. to the N. line of T. 26N.; thence W. to the N.W. corner of T. 26N., R. 80W.; thence S. to S.W. corner of T. 26N., R. 80W.; thence E. to the S.E. corner of said T. & R.; thence S. to the S.E. corner T. 25N., R. 80W.; thence W. to the N.W. corner of T. 24N., R. 80W.; thence S. to the S.W. corner of said T. & R.; thence E. to the S.E. corner of said T. & R.; thence S. to the S.W. corner of T. 22N., R. 79W.; thence E. to the original point of beginning.

DISTRICT NO. 8 - HANNA

All that area encompassed by the following closed perimeter description shall be known as ELECTION DISTRICT NO. 8:

Beginning at a point which is the S.E. corner of T. 21N., R. 81 W.; thence N. to the S.E. of T. 22N., R. 81W.; thence E. to the S.E. corner of T. 22N., R. 80W.; thence N. to the N.E. corner of T. 23N., R. 80W.; thence W. to the S.E. corner T. 24N., R. 81W.; thence N. to the N.E. corner of said T. & R.; thence W. to the N.W. corner of said T. & R.; thence S. to the S.W. corner of said T. & R.; thence W. to N.W. corner of T. 23N., R. 83W.; thence S. to the S.W. corner of T. 21N., R. 83W.; thence E. to the original point of beginning.

DISTRICT NO. 9 - ELK MOUNTAIN

All that territory embraced within the following Townships shall be known as ELECTION DISTRICT NO. 9: All of T. 18 N., R. 81W.; all of Townships 18, 19, 20 and 21, Range 80 West; all of Townships 20 and 21 North, Ranges 78 and 79 West; all of that portion of Townships 20 and 21 North Range 77 West, lying within Carbon County.

DISTRICT NO. 10 - MCFADDEN

All that territory embraced within the following Townships shall be known as ELECTION DISTRICT NO. 10: All of Townships 17, 18 and 19 North, Ranges 78 and 79 West; and all that portion of Townships 17, 18, and 19 North Range 77 West, lying within Carbon County.

DISTRICT NO. 11 - SARATOGA

All of the following described territory shall be included within and known as ELECTION DISTRICT NO. 11: All of Townships 19 and 20 North, Range 81 West; all of Townships 17, 18, 19 and 20 North, and Section 1 to 6 inclusive of Township 16 North, all in Range 82 West; all of Township 17 and 18 North, Ranges 84 and 85 West; all Townships 16 and 17 North, Range 86 West, and all Township 17 North Range 87 West, all of Township 15 Range 83W., West of the Encampment Highway, all Townships 15 and 16 N. Range 84W., and Townships 15 and 16N Range 85W. all of Township 16 N. Range 83W.; all of Townships 17, 18, 19, and 20 North, and Section 1 to 6 inclusive of Township 16 North, all in Range 83 West.

DISTRICT NO. 12 - ENCAMPMENT

All of the following described territory shall be included within and known as ELECTION DISTRICT NO. 12: All of Townships 14, N. Range 86W., also all of Townships 12, 13 and 14, Ranges 84 and 85, all of Township 15 N. Range 83 W. East of Encampment Highway; and Townships 12 N. Ranges 80, 81, 82 and 83W., and Townships 13 and 14 N., Ranges 80, 81, 82 and 83 W.

DISTRICT NO. 13 - BENNETT

All of the following described territory shall be included within and known as ELECTION DISTRICT NO. 13: All that territory embraced within Townships 15, 16 and 17 in Ranges 80 and 81, all of Township 15 North, Range 82; and all of Township 16, North Range 82 West of the 6th P.M., save and except all of Sections 1, 2, 3, 4, 5, and 6 in Township 16 North, Range 82 West of the 6th P.M.

DISTRICT NO. 14 - COLLINS

All of the following described territory shall be included within and known as ELECTION DISTRICT NO. 14: All that territory embraced within Township 12 North, Ranges 80, 81, 82 and 83 West, which lies in Carbon County; all of Townships 13 and 14 North, Ranges 80, 81, 82 and 83 West.

DISTRICT NO. 15 - SNAKE RIVER (BAGGS; DIXON, SAVERY)

All the following described territory shall be included within and known as ELECTION DISTRICT 15: All that territory embraced within Township 12 North, Ranges 86, 87, 88, 89, 90, 91, 92, and 93 West, which lies in Carbon County; all of Township 13 North, Ranges 86, 87, 88, 89, 90, 91, 92 and 93 West; all of Township 14 North, Ranges 87, 88, 89, 90, 91, 92 and 93 West; all of Township 15 North, Ranges 86, 87, 88, 89, 90, 91, 92 and 93 West; all of Township 16 North Ranges 87, 91, 92, and 93 West; all of Townships 17, 18 and 19 North, Ranges 91, 92, and 93 West.

DISTRICT NO. 16 - SINCLAIR (WALCOTT)

All that territory embraced within the following described shall be included within and known as ELECTION DISTRICT NO. 16:

All that territory embraced within Townships 19, 20, 21, 22, 23, and 24 North; Range 84 West; all of Townships 20, 21, 22, 23, and 24 North, Range 85 West; all of townships 21, 22, 23 and 24 North Range 86 West; all of the East one-half of Townships 22, 23 and 24 North Range 87 West.

DISTRICT NO. 1 - PRECINCT 1 - RAWLINS

All that area South of the BPRR to South East and West City Limits. PERSHING SCHOOL. The following precincts will vote in Jeffrey Center.

DISTRICT NO. 3 - PRECINCT 1 - RAWLINS, FORMERLY FORD GARAGE

DISTRICT NO. 3 - PRECINCT 2 - RAWLINS, FORMERLY PENMAN MOTEL, MOUNTAIN VIEW SCHOOL AND WOMENS' CLUB

DISTRICT NO. 3 - PRECINCT 3 - RAWLINS, FORMERLY TRAVEL LODGE

BAGGS DISTRICT 15 - PRECINCT 1, residents will vote in the Baggs Parish House.
