Feb. 2, 1972-The Board resumed its session, all members present, John Niland Chairman.

RIVERSIDE-SOUTHWEST ROAD: A motion was made by Orton, seconded by McMillen and carried whereby the following resolution was adopted, to wit:

RESOLUTION

WHEREAS, the Board of County Commissioners of Carbon County, Wyoming, having by resolution dated the 6th day of July, 1971, initiated procedure to establish the road known as Riverside-Southwest Road, Project S-0401 (6); and

WHEREAS, NOTICE OF LOCATION OF SAID PUBLIC ROAD WAS DULY PUBLISHED ON JULY 14, 21 and 28, 1971, IN THE MANNER REQUIRED BY LAW; and

WHEREAS, no objections having been filed to the establishment of said road and all persons owning lands or claiming any interest in lands over or across which said road is located having executed and delivered right-of-way easements over said lands; which right-of-way easements have been recorded,

NOW, THEREFORE, BE IT RESOLVED that a road to be known as Project S-0401 (6), the Riverside-Southwest Road in Carbon County, Wyoming, described as follows:

Commencing at a point on the west boundary of Section 18, T.14N., R. 84W. from the northwest corner of Lot 4 of said Section 18 bears northerly a distance of 670 feet, more or less;

Thence in a northeasterly direction for a distance of approximately 7.1 miles across Sections 18, 17, 16, 9, 10, 3, 2, 11 and 12, all of T. 14.N, R. 84 W of the 6th P.M., Wyoming, to a point on the north corporate limits of the Town of Riverside, be, and the same is hereby located and established and a plat of said road be filed in the office of the County Clerk of Carbon County, Wyoming.

A motion was made by Orton, seconded by McMillen and carried whereby the following resolutions were adopted.

DEEP CREEK ROAD: I. R. 6-17 RESOLUTION

WHEREAS, THE Board of County Commissioners of the County of Carbon, is desirous of taking advantage of the provisions of Chapter 136, Session Laws of Wyoming, 1961, and Chapter 17, Session Laws of Wyoming, 1963, by cooperating with the State Highway Commission of Wyoming in the improvement of a county road, the location and extent of which is as follows:

Grading, draining, crushed gravel surfacing and miscellaneous work on 10.50 miles of the Deep Creek Road beginning at the Boundary of the Medicine Bow National Forest and extending southeasterly to an intersection with the Baggs-Riverside Road in the SE $\frac{1}{4}$, Section 3, T.13N., R.87W. The Commissioners appointed Harold M. Johnson and R. A. Hakala of Rawlins and Blake Fanning of Laramie as viewers on this proposed road.

BAGGS-RIVERSIDE ROAD: SC-CFM 6-16 RESOLUTION

WHEREAS, The Board of County Commissioners of the County of Carbon is desirous of taking advantage of the provisions of Section 24-38, 24-68 and 24-69, W.S.1957, by cooperating with the State Highway Commission of Wyoming in the construction and / or the improvement of a county road, the extent and location of work which is as follows:

Sub-grade preparation, crushed gravel surfacing and miscellaneous work on 5.75 miles of the Baggs-Riverside Road from the east end of Project S-0401 (3) to a junction with the Deep Creek Road.

NOW, THEREFORE, be it resolved by said Board:

THAT the Board enter into a written agreement with said Commission covering said construction and/or improvement in accordance with a contract therefor; now submitted to said Board by said Commission, which agreement is hereby approved and ordered filed in the office of the County Clerk of said County; that the chairman of said Board and the County Clerk of said county be, and they are hereby authorized and directed to execute said contracts on behalf of said Board.

I, the undersigned, County Clerk of Carbon County, State of Wyoming, do hereby certify that at a legal meeting of the Board of County Commissioners at which a quorum was present, said Board adopted these resolutions of which the forgoing is a full, true and complete copy.
