SPECIAL MEETING

The Commissioners met at 9:00 A. M. all members present, John Niland Chairman.

A Motion was made by Orton and seconded by McMillen and carried whereby the following Resolution was adopted, to wit:

R E S O L U T I O N

WHEREAS, Carbon County, Wyoming, experienced a severe winter and spring during the 1972-1973 fall, winter and spring; and

WHEREAS, Carbon County, Wyoming, is a substantial livestock and farm county in the State of Wyoming with two hundred ninety six (296) farms and ranches in said county; and

WHEREAS, the Farmers Home Administration, United States Department of Agricultural, by report of natural disaster for consideration in designating emergency loan area in Carbon County, Wyoming, by letter dated August 27, 1973, feels there is a definite need for emergency assistance in Carbon County; and

WHEREAS, the financial institutions and banks have loaned millions of dollars more than was anticipated and the economy is presently under a current tight money situation; and


WHEREAS, the said Farmers Home Administration by and through Arthur E. Hawkinson, Jr., County Supervisor, Casper, Wyoming, has requested a designation of Carbon County, Wyoming, as a disaster area; and

WHEREAS, the Board of County Commissioners duly assembled this date are in agreement and concur that said County of Carbon in the State of Wyoming, should be so designated a disaster area for emergency loans.

NOW, THEREFORE, be it resolved that Carbon County, Wyoming by reason of the foregoing severe winter and snow storms during the 1972-1973 fall, winter and spring, be, and the same is hereby designated an emergency loan area.


