## REGULAR MEETING

TRANSFER OF FUNDS FROM CASH RESERVE: In compliance with Art.3 Sec. 9-535 of Municipal Budget Act. W.S. 1957, a notice of hearing on the proposed transfer of funds from the Cash Reserve was advertised on June 22, 1974 in the Daily Times. MALT BEVERAGE LICENSE: There being no protests entered, Malt Beverage License No. 325 was re-newed for Overland Trail Inn, Inc. Arlington,Wyo. July 7, 1974 to July 7, 1975-for the sum of \$100.00.

CONTRACT AGREEMENT: A contract agreement was entered into between the Carbon County Board of Commissioners. and the Snowy Range Community Action Agency, Inc.of Laramie, Wyo.for a period of one year, July 1, 1974 to June 30, 1975.No money shall change hands between the parties. The signed agreement is on.file in the office of County.Clerk.

ELECTION BOARD-SALARIES. A motion was made by Orton, Seconded by McMillen and carried,whereby it was agreed to pay Election judges \$1.75 per hour. The new Election.Code designates all Boad members as Judges.

MOUNTAIN BELL: The Board granted permission for the placing of a telephone plant on County Right of.Way, R/W No. 12125, Job No. WS-1085-Line No. R. L. 13M, 13,13J,13F.Portions of Sec.21,33,28 Twp.24N Rg.81W.; Sec. 14 Twp. 26N, Rg.84W; Sec. 1-5-8-9-16-28, Twp.26N Rg. 83W; Sec. 9-16-28-29-33,Twp.23N, 81W; and Sections 11-12-13 Twp. 24N. 83W;

PROPOSED ARLINGTON-McFADDEN ROAD: A motion was made by Orton, seconded by McMillen and carried whereby the following resolution was adopted,to wit:

RESOLUTION

WHEREAS, it is necessary for the location, construction and maintenance of a public road to acquire certain real estate for the Arlington-McFadden Road in eastern Carbon County, Wyoming; and

WHEREAS, the Board of County Commissioners of Carbon County, Wyoming and the owners of the real property to be traversed by said proposed Arlington-McFadden Road cannot agree

upon the compensation to be paid by Carbon County, Wyoming, to the owners of said lands for right-of-way thereon; and

WHEREAS, pursuant to the statute in such case made and provided, the Board of County Commissioners of Carbon County, Wyoming, deem it necessary to authorize, empower and direct Oscar A. Hall, County and Prosecuting Attorney in and for Carbon County, Wyoming, or his duly authorized deputy, to institute condemnation proceedings to acquire right-of-way for lands for said road.

NOW, THEREFORE, BE IT RESOLVED that Oscar A. Hall, County and Prosecuting Attorney in and for Carbon County, Wyoming, or his duly authorized deputy, be, and he is hereby authorized, empowered and directed to initiate and conclude condemnation proceedings in the name of Board of County Commissioners of the County of Carbon to acquire by condemnation the necessary and required right-of-way for said Arlington-McFadden public road.

Special Meeting

A Motion was made by McMillen, seconded by Niland whereby the following resolution was adopted, to wit:

Resolution

WHEREAS, under the provisions of the Section 5-85 WCS 1957 as amended, Carbon County has been assigned two Justices of the Peace effective January 1, 1975; and

WHEREAS, the Primary and General Elections of 1974 will nominate and elect these Justices, and

WHEREAS, no designation of Justice of Peace Districts has been made, and

WHEREAS, it is deemed, to the public interest that Justice of Peace Districts are necessary.

NOW THEREFORE, be it resolved, that Carbon County be divided into two Justice of Peace Districts, and it hereby is, as follows.

Rawlins Justice of Peace District shall encompass all that area comprising School District No. 1.

Elk Mountain Justice of Peace District shall encompass all that area comprising School District No. 2.

BE IT FURTHER RESOLVED that a Justice of the Peace shall be elected or appointed from each district.
