MEMORIAL HOSPITAL BOARD: The Board reappointed Joe Mullen as a member of the Board of Trustees for a five year period ending July 1, 1979.

U. P. R. R. CO. HANNA OVERPASS: A motion was made by McMillen and carried where by the following resolution was adopted:

RESOLUTION

WHEREAS, UNIONPACIFIC RAILROAD COMPANY, has tendered to COUNTY OF CARBON, State of Wyoming, an agreement covering the construction, maintenance and use of a public roadway across the right of way and over ~~exist~~ the over the track of the Railroad Company and a 32.5-foot plank crossing on said right of way and over said track in Carbon County, Wyoming; said agreement being identified in the records of the Railroad Company as its C. D. No. 52121-4-9; and

WHEREAS, THE Board of County Commissioners of County of Carbon, State of Wyoming, has said proposed ^{ROAD} agreement before it and has given it careful review and consideration; and

WHEREAS, it is considered that the best interests of said County of Carbon, State of Wyoming, will be subserved by the acceptance of said agreement;

THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF COUNTY OF CARBON, STATE OF WYOMING:

That the terms of the agreement submitted by Union Pacific Railroad Company as aforesaid be and the same hereby are accepted in behalf of said County;

That the Chairman of the Board of County Commissioners of said County is authorized, empowered and directed to execute said agreement on behalf of said County, and that the County Clerk hereby is authorized and directed to attest said agreement and to attach to each duplicate original of said agreement a certified copy of this resolution.

SENIOR CITIZENS HOME

A motion was made by Orton, seconded by McMillen and unanimously carried whereby the following resolution was adopted, to wit:

RESOLUTION

WHEREAS, Carbon County, Wyoming, a body politic and corporate is the owner of all of Block Forty (40), Sixth Park Hill Addition to the City of Rawlins, Carbon County, Wyoming;

WHEREAS, Senior Citizens Home is a Wyoming corporation organized for the exclusive purpose of engaging in the erection and maintenance of boarding homes suitable for the reception and care of elderly persons, and

WHEREAS, all of Block Forty (40), Sixth Park Hill Addition to the City of Rawlins, known as old Memorial Hospital of Carbon County, is no longer in use; and

WHEREAS, Senior Citizens Home has offered to take and hold said premises and improvements, remodel the same and devote said property exclusively to the care of senior citizens and elderly persons; and

WHEREAS, said property should be conveyed to Senior Citizens Home, a Wyoming corporation, on condition subsequent that the said property shall revert to Carbon County, Wyoming when it is no longer devoted exclusively to care and housing of senior citizens and elderly persons by said Wyoming corporation, its successors or assigns, and

WHEREAS, The Board of County Commissioners of Carbon County, Wyoming is duly and regularly convened and do resolve and determine that all of Block Forty (40), Sixth Park Hill Addition together with all improvements thereon situate and all appurtenances thereunto belonging should be conditionally conveyed to Senior Citizens Home, a Wyoming corporation, or its successors or assigns, upon the following express condition:


That said Block Forty (40), Sixth Park Hill Addition and improvements be conveyed for a nominal consideration of ONE Dollar (\$1.00) and upon the further express condition subsequent that it be used solely and exclusively by said grantee, Senior Citizens Home, a Wyoming corporation, its successors or assigns, as and for a home for senior citizens and elderly persons, and for no other purpose; and that upon breach of said condition it shall and may be lawful to and for the said grantor, Carbon County, Wyoming, a body politic and corporate, into the premises hereby conveyed or unto any part in the name of the whole to re-enter and the same to have again, possess, occupy and enjoy as in its former estate and then in such case this deed shall from thenceforth be utterly void and of no effect in law and equity and any and all estate and interest of said grantee, its successors or assigns, shall be forfeited.


NOW THEREFORE BE IT RESOLVED: That the Chairman of the Board of County Commissioners of Carbon County, Wyoming and the County Clerk are hereby authorized, directed and empowered to execute and deliver to Senior Citizens Home, its successors or assigns, a Quitclaim Deed in Wyoming statutory form, Section 33-44 Wyoming Statutes, 1957, upon the nominal consideration of One Dollar (\$1.00) and with condition subsequent in the following form:

that all of said Block Forty (40), Sixth Park Hill Addition be used solely and exclusively by the grantee, Senior Citizens Home, a Wyoming corporation, its successors or assigns, as and for a home for senior citizens and elderly persons and for no other purpose, and that upon breach of said condition it shall and may be lawful to and for the said grantor, Carbon County, Wyoming, a body politic and corporate, into the premises hereby conveyed or unto any part thereby in the name of the whole to re-enter and the same to have again, possess, occupy and enjoy as in its former estate and then in such case this deed shall from thenceforth be utterly void and of no effect in law and equity and any and all estate and interest of said grantee, its successors or assigns shall be forfeited.

BE IT FURTHER RESOLVED that this resolution be made a matter of public record and be spread at large upon the minutes of this meeting and also be recorded in the office of the County Clerk and Ex-Officio Register of Deeds, Carbon County, Wyoming.


