## COMMISSIONERS PROCEEDINGS

## SPECIAL MEETING

The Board met at 3:00 P.M., Niland absent, McMillen and Orton present, Orton, Chairman Pro-Tem. The Board met for the purpose of adopting a resolution relative to the Wyoming Administrative Procedure Act as required within Section 9-276.19.

A motion was made by Orton, seconded by McMillen and carried whereby the following resolution was adopted, to wit:

RESOLUTION

WHEREAS, the Board of County Commissioners of Carbon County, Wyoming, is an agency within Section 9-276.19 of the Wyoming Administrative Procedure Act; and

WHEREAS, pursuant to said act the Board must adopt rules of practice, setting forth the nature and requirements of all formal and informal procedures available in connection with contested cases before said Board; and

WHEREAS, proposed Rules of Procedure have been prepared and placed of record with the County Clerk of Carbon County, Wyoming; and

WHEREAS, notice of public hearing and filing Rules of Practice has heretofore been published in the Rawlins Daily Times on October 30, November 6, 13, 19, 1974; and

WHEREAS, The Board of County Commissioners is duly convened on Wednesday, November 20, 1974, at 3:00 o'clock P.M. in the Commissioners Chambers, Room 104, Carbon County Courthouse Bldg. at Rawlins, Wyoming, for public hearing for the purpose of affording all interested persons reasonable opportunity to submit data, views or arguments, orally or in writing to said proposed Rules of Procedure; and

WHEREAS, there being no written and oral submissions respecting the proposed Rules of Procedure submitted to the Board of County Commissioners of Carbon County, Wyoming, at said meeting duly convened; and

WHEREAS, the Board finds that the said Rules of Practice pursuant to the Wyoming Administrative Procedure Act should be approved and adopted by said Board; and

WHEREAS, pursuant to said approval and adoption the Board further finding that said Board of County Commissioners shall file forthwith in the office of the Secretary of State, State of Wyoming, a certified copy of such Rules of Practice approved and adopted at this meeting

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Carbon County, Wyoming, duly convened this 20th day of November, 1974, that the attached Rules of Practice pursuant to the Wyoming Administrative Procedure Act be, and they are hereby approved and adopted.

BE IT FURTHER RESOLVED that the County Clerk of Carbon County, Wyoming, shall forthwith file with the office of the Secretary of State, State of Wyoming, a certified copy of said Rules of Practice as hereby adopted.

BE IT FURTHER RESOLVED that said Rules of Practice shall be in full force and effect twenty (20) days after filing with the Secretary of State, State of Wyoming.
