## REGULAR MEETING

The Board met at 10:00 A. M. all members present, John Niland, Chairman.

WHEREAS, It was decided to equalize the number of voters in Rawlins District No.2, precincts No. 1 and 2, for the benefit of the voters as described in the Commissioners meeting of Jan. 2, 1974, and

WHEREAS, the Commissioners have approved the map, outlining the districts and precincts in Carbon County, this map is on file in the office of County Clerk, now

THEREFORE, be it resolved that the above resolution be adopted this 5th day of February, 1974

The Board then adjourned until the following day.

Feb. 6, 1974, The board resumed its session, all members present, John Niland-Chairman.

PUBLIC DEFENDERS: The Board entered into another agreement with the law firms of C. L. Bates and Brimmer, MacPherson and Golden pursuant to the provisions of Chapter 164, Session Laws of Wyoming, 1973 to act as Public Defenders as of Jan. 6, 1974 for a period of six months. The compensation shall be \$8000.00 payable on or about the first day of each calender month, in 6 equal monthly installments.

CARBON COUNTY HOUSING AUTHORITY: On Jan. 9, 1974 the Board of Commissioners adopted a resolution to establish a Carbon County Housing Authority. The Board found it necessary to amend this resolution. A motion was made by Orton, seconded by McMillen and carried whereby the following amended resolution was adopted, to wit:

#### AMENDED RESOLUTION

WHEREAS, there is unsanitary, unsafe, and substandard inhabited dwelling accommodation in Carbon County; and

WHEREAS, there is a shortage of safe and sanitary dwelling accomodations in Carbon County available to persons of low income at rentals or prices they can afford; now, therefore,

BE IR RESOLVED, by the Board of County Commissioners that;

The County of Carbon, Wyoming, herein exercises those housing powers authorized by Section 24, 1-2 and 24, 1-16 of Wyoming Statutes.

LIMITED LIQUOR LICENSE: A renewal of Limited Liquor License was applied for by George W. Schaffer of Medicine Bow Snowmobile Club on Jan. 7, 1974. The advertising was completed and authorized by Mr. Schaffer in the Saratoga Sun. Mr. Schaffer left the country, the applications were not completed, so no action was taken by the Commissioners.

OLD HOSPITAL BUILDING: The following letter was sent to all members of the Memorial Hospital Board:

The Board of County Commissioners at the regular February meeting have decided that all water and natural gas services to the old hospital building shall be discontinued and turned off at once. The water heaters, boilers, toilets and water lines should be drained and the premises otherwise protected against freezing. The Maintenance agreement shall be terminated effective March 1, 1974.

There being no further business, the meeting was adjourned.
