CARBON COUNTY HISTORICAL MUSEUM: The Board took under consideration the gift and devise to Carbon County, Wyoming, under the Will of the late Clifford Sundin of all of Lots 7 and 8, Block 53, Union Pacific 5th Addition to the City of Rawlins, also known as 703 West Maple Street to be used for museum purposes and as a memorial to Ernest Sundin and Margaret Sundin. It was the consensus of the Board that it would be financially burdensome and contrary to the best interests of Carbon County to accept such devise and that the same should be renounced. It was then regularly moved by Glode and seconded by Lemich and unanimously carried by voice vote to reject the said gift and devise of the late Clifford Sundin.
