RAWLINS-CARBON COUNTY REGIONAL PLANNING COMMISSION. The following reports were submitted: A Housing Analysis for Carbon County, June 1975, A Recreation Plan (2nd Year), Carbon County, June 1975, a Transportation Study for Carbon County, June, 1975 and a map of the Carbon County-BLM Road Systems.
