CARBON COUNTY WEED AND PEST CONTROL DISTRICT. Members of the Weed and Pest Control Board met to discuss the mill levy which was set at .87 for the 1975-76 budget. Bob Holmes was appointed to the Weed and Pest Control Board to fill the unexpired term of Bruce Richardson, his term to expire 5-1-79.

WESTERN AREA AGENCY ON AGING - The Commissioners appropriated \$10,500.00 to the WWAAA from Revenue Sharing. WWAAA will pay the balance of the funding which was allocated earlier.

Final approval will be granted upon receipt of an irrevocable letter of credit in the amount of \$10,000.00 as a performance guarantee for the performance of road construction and notification of compliance with the recommendations of the County Planning Commission.
