TRANSFER OF FUNDS FROM CASH RESERVE: In compliance with Art. 3, Sec. 9-535, Municipal Budget Act, W. S. 1957, a Notice of Hearing on the proposed transfer of funds from the Cash Reserves was advertised on March 29, 1975. There being no protests entered, the Board approved the transfer of funds as follows on motion by Orton, seconded by Glode and unanimously carried, as follows:

RESOLUTION INDICATING INTENT TO JOIN WITH OTHER  
UNITS OF LOCAL GOVERNMENT TO OBTAIN GRANT MONEY  
FROM THE OLD WEST REGIONAL COMMISSION THROUGH THE  
DEPARTMENT OF ECONOMIC PLANNING AND DEVELOPMENT

WHEREAS, the Old West Regional Commission has made a grant available to the Department of Economic Planning and Development of the State of Wyoming for the purpose of providing aid to impacted areas of southwest Wyoming; and

WHEREAS, this grant is to be used to establish an office of Southwest Wyoming Studies Director, whose duties shall include coordination of efforts to cope with and plan for coal and other mineral development in the area; and

WHEREAS, it is recognized that this resolution indicates intent only and that Carbon County is not obligated until a contract or other such instrument is signed.

NOW, THEREFORE, BE IT RESOLVED THAT Carbon County, Wyoming, recognizing that southwest Wyoming has substantial problems resulting from coal and mineral development impact, does support the establishment of an office for a Studies Director.

BE IT FURTHER RESOLVED THAT Carbon County, Wyoming, intends to join with other units of local government to establish said office.
