ROCKY MOUNTAIN ENERGY COMPANY:

A meeting was held in the office of the Commissioners to discuss with community leaders and representatives from the Rocky Mountain Energy Company the effects of impact the future development of coal in the Southwest corner of Carbon County will have on the County.

GRANTS FROM LAW ENFORCEMENT ASSISTANCE ADMINISTRATION:

In compliance with Art. 3, Sec. 9-535, Municipal Act, W.L. 1957 the following unanticipated funds were received and will supplement the following budgets. Grants from Law Enforcement Assistance Administration will be used for architectural services for the Sheriff's Office expansion and furniture and remodeling for the Justice of the Peace Office, Rawlins. Any and all persons may be heard with reference to said funds at the May 4, 1976 meeting of the Board of County Commissioners in their office in the Courthouse at 11:00 A.M. Sheriff B-5 Subgrant Award 75A-31-144, \$6,644.00. Justice Court B-12, Subgrant Award 75A-33-077, \$4,513.00 and Subgrant Award 75A-33-078, \$3,586.00. Total Grant Money \$14,743.00.
