MINERALS EXPLORATION COMPANY ROAD IN SWEETWATER AND CARBON COUNTIES, WYOMING:

The construction of the roadway approximately 30 miles in length to serve the proposed facility of Mineral Exploration Company located in Section 5, Township 24N, Range 83W, shall conform to the Standard County Road Detail, dated August, 1974; however, the initial construction of the roadway will be completed only to the subgrade level.

The base, asphalt surface and chip seal coat will be completed at a future date which will be determined by Minerals Exploration Company. However, it is understood that Carbon County will assume no additional maintenance responsibility as a result of the delay in the construction of the surfacing materials.

CARBON COUNTY, WYOMING-TOWN OF SARATOGA, WYOMING

Survey of Right-of-Way No. 16151 (Amend.) Buried Telephone Cable-Carbon County, Wyoming, for proposed Encampment R L 2 and 2-G line to be constructed across Section 8, Township 15N, Range 82W and Section 28, Township 16N, Range 82W of the 6th P.M. was approved by the Board of Commissioners.

Road

APPLICATION FOR RIGHT OF WAY ACROSS STATE OR SCHOOL LANDS:

The Board of County Commissioners hereby apply for a right of way for a road, 100 feet in width being 50 feet on each side of centerline across the following described land;

A 100 foot wide road easement being a portion of the NW¼ NW¼ Sec. 11, T. 27N., R. 78W., Carbon County, Wyoming.

Said road to traverse or cover the portions of the above described land as more particularly set forth on the map attached hereto and made a part hereof. The course of said road being more particularly described as follows;

Beginning on the line between Secs. 2 and 11, T. 27N, R. 78W, at a point on the centerline of a 100 foot wide road easement from which the W 1/16 Cor. of Secs. 2 and 11 bears N. 89° 01' E., 416.2 ft. dist.; Thence from the point of beginning 436.5 ft. along a true curve to the right haveing a radius of 1744.3 ft. to the end of said true curve; Thence continuing along the centerline of said road easement on a true curve to the right having a radius of 459.0 ft. for a distance of 51.0 ft. to a point on the East line of the said NW¼ NW¼ Sec. 11 and the end of said 100 ft. wide road easement.

Note: The above bearings refer to the Wyoming State Plane Coordinate System, East Central Zone.
