BIDS FOR REMODELLING AND EXPANSION OF SHERIFF'S OFFICE. Bids were opened for the remodelling and expansion of the Sheriff's office. The contract was awarded to Arrow Construction Company for their low bid of \$13,777.00.

RAWLINS MUNICIPAL AIRPORT. Interested citizens met with the Commissioners concerning county participation in the improvement of the airport. A motion was made by Glode and seconded by Lemich to budget \$14,000.00 for this project.

THE HICKMAN ADDITION. The Board approved the recording of the plat of the Hickman Addition to the City of Rawlins.

MINERAL EXPLORATION COMPANY. Representatives from Mineral Exploration Co. met with the Board to discuss finalizing of the construction of their proposed road from Highway No. 287 west to Sweetwater County. The matter was taken under advisement.

CARBON COUNTY AGING SERVICE. A Federal grant for the Carbon County Aging Service for Title III funds in the amount of \$9,683.70 was approved. A Federal grant for Title VII Nutrition budget was approved in the amount of \$80,372.96, John Glode, County Commissioner, being the project official.

PAYMENT REFUSED. A voucher in the amount of \$795.55 presented by the Carbon County Memorial Hospital for the care of Betty Lennox was refused.

REPORT OF STATE EXAMINER. The Board and county officers concurred with the State Examiner in the suggestions he made in his report on the examination of Carbon County Offices as of the close of business March 31, 1976, and the Board requested the officials to adjust their methods in compliance therewith, as attested by their signatures on the Examiner's report. The report was placed on file.
