A regular meeting of the Board of County Commissioners of the County of Carbon, State of Wyoming, was held in the Commissioners' Chambers, Courthouse Building, Rawlins, Wyoming, on Tuesday, September 7, 1976 at the hour of 10:00 o'clock A.M.

The meeting was called to order by the Chairman of the Board of County Commissioners and upon roll call the following members were found to be present:

Commissioner:	John Glode
Commissioner:	Emil T. Lemich
Absent:	None

Thereupon, Petitioners were presented to the Board requesting that the Commissioners submit to the qualified electors of Carbon County, Wyoming, a question for the purpose of raising taxes for general revenue by means of a one percent (1%) County Sales Tax. A Certificate of the County Clerk as to the validity of said Petition was also presented to the Board. Discussion was held by the Board and thereupon Commissioner Lemich introduced the following resolution:

R E S O L U T I O N

WHEREAS, The County of Carbon herein referred to as the "County", is a duly organized, established and existing County in the State of Wyoming, and is a body politic and corporate; and

WHEREAS, the Board of County Commissioners of Carbon County, Wyoming, is the duly elected, qualified and acting governing body of the County of Carbon, delegated by law to exercise the powers of the County as a body politic and corporate; and among those powers is the power to apportion and order the levying of taxes as provided by law, which includes the power to impose an excise tax at the rate in increments of one-half ($\frac{1}{2}$) of one percent (1%) upon retail sales of tangible personal property and the other transactions set forth in Section 39-291, Wyoming

Statutes, 1957, as amended, made within Carbon County, Wyoming. And the purpose of such tax being for general revenue; and

WHEREAS, the Commissioners have determined that there is a need to expand the County governmental services due to the influx of new residents in Carbon County, Wyoming, precipitated by the national energy demands; and

WHEREAS, said services are creating the need for additional general revenue; and

WHEREAS, it is the desire and intention of the Board of County Commissioners to provide such services as quickly as possible and at the least possible inconvenience to the habitants of Carbon County; and

WHEREAS, the Board of County Commissioners have received Petitions signed by in excess of ten percent (10%) of the qualified electors voting at the last General Election in Carbon County, Wyoming; and

WHEREAS, the County Clerk of Carbon County, Wyoming, has filed her Certificate with said Board certifying that she, or her duly authorized and qualified deputies, have examined all the signatures on said Petitions and she has certified that all of the signatures so noted, examined and remaining on said Petitions are qualified electors in and for Carbon County, Wyoming, and that she has further certified that in excess of ten percent (10%) of the qualified electors voting at the last General Election held in Carbon County, Wyoming, are affixed to said Petitions; and

WHEREAS, Section 39-288 provides that upon the receipt of such Petitions the Board of County Commissioners of Carbon County, Wyoming, shall submit the proposition to impose such one percent (1%) excise tax to the qualified electors of Carbon County, Wyoming, at any General or Primary Election or Special Election called for the specific purpose; and

WHEREAS, such election shall be at the expense of Carbon County, Wyoming, and be submitted under the supervision of the Board of County Commissioners; and

WHEREAS, such proposition to impose within said Carbon County, Wyoming, an excise tax of one percent (1%) upon retail sales of tangible personal property and the other transactions set forth in Section 39-291, Wyoming Statutes, 1957, as amended, should be submitted to the qualified electors of Carbon County, Wyoming at the General Election on November 2, 1976 in the form and manner as hereinafter set forth.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF CARBON AND STATE OF WYOMING:

Section 1: That the question to impose an excise tax of one percent (1%) upon retail sales of tangible personal property and the other transactions set forth in Section 39-291, Wyoming Statutes, 1957, as amended, be submitted at the General Election in Carbon County, Wyoming, to be held on Tuesday, the 2nd day of November, 1976 between the hours of 8:00 o'clock A.M. and 7:00 o'clock P.M. at which election there shall be submitted to the qualified electors of Carbon County, Wyoming, the question set forth in the form of Proclamation and Notice of Election as hereinafter set forth.

Section 2: The election shall be conducted as provided by the statutes of the State of Wyoming for voting at a General Election.

Section 3: That the Proclamation and Notice of Election shall be made and given by the County Clerk in the form as provided hereinafter. That such Proclamation and Notice of Election shall be given by publication in Carbon County, Wyoming, in the following newspapers on the dates set forth, namely:

Rawlins Daily Times: October 2, 9, 16, 23, 30, 1976

Saratoga Sun: October 7, 14, 21, 28, 1976

Snake River Press: October 7, 14, 21, 28, 1976.

Section 4: The Notice of Election and Proclamation shall be simultaneously published in the English and Spanish languages and shall be in the following form:

MCFADDEN-ARLINGTON ROAD. James Kandolin, representing the Wyoming Highway Department, conferred with the Commissioners on minor changes regarding the McFadden-Arlington Road. He also reported that this road is now open to traffic.

BUREAU OF LAND MANAGEMENT. The Board signed a memorandum of understanding between the Rawlins-Carbon County Regional Planning Commission, Carbon County and the Bureau of Land Management to work together in gathering land and resource information and in developing their respective comprehensive management plans. The agreement is aimed at reducing any duplication of efforts between the county and the BLM and to achieve maximum efficiency from their respective funds and personnel. The agreement provides for the Rawlins-Carbon County Regional Planning Office to be the common contact for coordination between Carbon County and the BLM.

BONDS APPROVED. The bond of Andrew T. Morehead, Savery, Wyoming, as Treasurer for the Reader Cemetery Special District, 5-19-76 to 5-19-77, in the amount of \$3,000.00, was approved.

The Bond of Joyce H. Neuman, Rawlins, Wyoming, Treasurer of the Board of Trustees of Jeffrey Memorial Center, 8-14-76 to 8-14-77, in the amount of \$5,000.00, was approved.

MALT BEVERAGE PERMIT. There being no protests entered, the Commissioners granted a renewal of a Retail Malt Beverage Permit to Frank E. and Roberta Erickson dba 3 Forks Muddy Gap Service, Three Forks, Lander Route, Rawlins, Wyoming, License No. 350, 9-8-76 to 9-8-77.

Thereupon the Board adjourned until the following day.

BAGGS SOLID WASTE DISPOSAL DISTRICT.

R E S O L U T I O N .

WHEREAS, the inhabitants of the Town of Baggs, Carbon County, Wyoming, and the surrounding area have requested that the Board of County Commissioners of Carbon County, Wyoming establish the BAGGS SOLID WASTE DISPOSAL DISTRICT in that area; and

WHEREAS, that Board of County Commissioners of Carbon County, Wyoming, find that the influx of people into the Baggs area of Carbon County has caused a need and necessity for the establishment of said district in the Baggs and surrounding area; and

WHEREAS, it appears that the Baggs Solid Waste Disposal District should encompass the following described land, namely:

Township 12 North, Range 91 West of the 6th P.M.
