## AGRICULTURAL EXTENSION SERVICE

A G R E E M E N T

THIS AGREEMENT, Made and entered into by and between the University of Wyoming, hereafter referred to as the University, and the Board of County Commissioners of Carbon County, hereafter referred to as the County.

WITNESSETH: That Whereas, it is desired by the County to employ, under the Federal Smith Lever Act and the State Acceptance Act of 1915 and amendments thereto covering Extension Work in Agriculture and Home Economics, a University Extension Agent for the purpose of assisting and encouraging the general development of agriculture throughout Carbon County, and that said work shall be done and directed under the supervision of the Associate Director of the Agricultural Extension Service of the University of Wyoming;

NOW THEREFORE, For and in consideration of the covenants and agreements of each to the other running, and for other good and valuable consideration, as herein contained, the said parties agree as follows:

That each party to this agreement shall contribute annually to support the work, the cash sum, equipment and services indicated by the following schedule:

COOPERATING PARTIES	CASH CONTRIBUTIONS FOR:
University of Wyoming Agricultural Extension Service	Salary and Travel \$1,248
County of Carbon	\$10,320 plus necessary travel expenses

The County agrees to make its contribution to the University. The University will in turn make total disbursement of salary to the University Extension Agent being employed in the county.

Final payment of the annual contribution from the County must be received by the University prior to June 30 of each year.

In order that the University may receive the total County contributions for each fiscal year before June 30 of such year, the County agrees to make payments to the University as follows:

Option I. Twelve equal monthly installments becoming due on the 10th of August and the 10th day of each succeeding month except that the last two installments will be paid by June 10th.

THE TERMS AND CONDITIONS OF THIS AGREEMENT shall be and remain in force and effect from July 1, 1977 until June 30, 1979 unless terminated by mutual consent of the two parties involved.

In event this position becomes temporarily vacant the unused funds contributed by the County will be credited toward salary for a replacement; if the agreement is terminated the unused funds will be refunded to the County by the University.

IN WITNESS WHEREOF, the Board of County Commissioners of Carbon County, has caused this agreement to be executed by its Chairman on this 7th day of June, 1977, and the University of Wyoming has caused the same to be executed by the President of the University of Wyoming on this 22d day of July, 1977.

WHEREAS, The Board of County Commissioners must assure legal counsel for all indigent defendants charged in the Courts of Carbon County, Wyoming; and

WHEREAS, The Commissioners have duly considered that certain agreement dated August 19, 1977, between the Board of County Commissioners of Carbon County, Wyoming, on the one part and the law firm of MacPherson, Golden and Brown, Public Defender, on the other part; and

WHEREAS, it appears that it is in the best interest and general welfare of the said Board and the inhabitants of Carbon County, Wyoming, that said Board of County Commissioners should execute said agreement effective July 1, 1977, for compensation to be paid to said public defenders at the rate of Twenty-two Thousand Dollars (\$22,000.00) annually payable in twelve (12) equal monthly installments on or about the 1st day of each calendar month, commencing July 1, 1977, and terminating June 30, 1978; and

WHEREAS express authority for execution and delivery of a copy of such instrument should be made a matter of record,

NOW, THEREFORE, BE IT RESOLVED that John Glode, Chairman of the Board of County Commissioners, and Mary G. Bradford, County Clerk, be and they are hereby authorized to execute in behalf of said Board of County Commissioners the original agreement hereto attached, dated August 19, 1977.

BE IT FURTHER RESOLVED that an executed copy of this agreement be delivered by said County Clerk to MacPherson, Golden and Brown, Attorneys at Law, First National Bank Bldg., Rawlins, Wyoming.

#### MEMORANDUM

SUBJECT: Court appointed attorney fees for all cases not covered by the defender contract.

TO: All members of the Carbon County Bar Association.

FROM: Board of County Commissioners, Carbon County.

Date: September 6, 1977

It is necessary from time to time to appoint attorneys in legal proceedings not covered by the defender contract, or in situations in which there is an apparent conflict of interest with the defender service.

It must, therefore, be established by the Board as a firm policy that a limitation be placed upon the payment of fees for cases in this category.

Accordingly, fees will hereafter be allowed at the rate of \$20.00 per hour of legal services rendered for a maximum of 50 hours of legal time expended. All vouchers must be accompanied by attachment showing the actual hours expended, and the attached statement of hours shall be deemed to be verified as part of the voucher.

Expenses will be authorized as follows:

1. Travel at 15¢ per mile for a distance not to exceed 100 miles.
2. Long distance telephone calls in an amount not to exceed \$20.00.
3. Xerox or other photo copy work not to exceed \$10.00.

Secretarial and office expense shall not be considered an allowable expense.

If any attorney seeks exception from this policy, he shall appear before the Board to present his special circumstances for exception.

SHIRLEY BASIN ACCESS ROAD TO (487-75)


