

A special meeting of the Board of County Commissioners of Carbon County, Wyoming, was held at 2:00 o'clock p.m. on November 10, 1977, in the Commissioners' chambers, Room 201, Courthouse Bldg., Rawlins, Wyoming, the regular meeting place of the Board, pursuant to due notice and call.

The Chairman called the meeting to order and upon roll call the following were found to be present, constituting a quorum:

Chairman: John Glode  
Commissioner: Martin R. McMahon  
Commissioner: Emil T. Lemich

There were also present: County Clerk, Mary G. Bradford County and Prosecuting Attorney, Oscar A. Hall.

Thereupon, the following proceedings, among others, were had and taken:

Commissioner McMahon submitted the name of Audrey B. Musgrave to serve on the Carbon County canvassing board in the absence of Dorothy J. Muir, who is hospitalized and unable to serve on said canvassing board. It was then regularly seconded by Commissioner Glode and unanimously carried that Audrey B. Musgrave, Mary G. Bradford and Gilbert Blumenthal constitute a canvassing board to canvas and certify the results of the county wide 1% sales tax election held November 8, 1977.

The certificate of canvas of the County canvassing board was then placed by the County Clerk with the Chairman of the Board of County Commissioners, which certificate reads as follows:

Commissioner Lemich then introduced an Ordinance entitled "An Ordinance Imposing an Excise Tax on Retail Sales of Tangible Personal Property and Other Transactions Set Forth in Section 39-291 of the Wyoming Statutes, 1957, as amended, Pursuant to the Authority of Section 39-288 of the Wyoming Statutes, 1957, as amended" which Ordinance was thereupon read in full and is as follows:

SALES TAX ORDINANCE  
OF CARBON COUNTY, WYOMING

AN ORDINANCE IMPOSING AN EXCISE TAX ON RETAIL SALES OF TANGIBLE PERSONAL PROPERTY AND OTHER TRANSACTIONS SET FORTH IN SECTION 39-291 OF THE WYOMING STATUTES, (1957), AS AMENDED, PURSUANT TO THE AUTHORITY OF SECTION 39-288 OF THE WYOMING STATUTES (1957), AS AMENDED.

WHEREAS, the Wyoming State Legislature has authorized the imposition of an excise tax by the several counties of the State of Wyoming; and,

WHEREAS, the Board of County Commissioners in and for Carbon County received a petition requesting the proposition to impose such tax be placed to the vote of the qualified electors of Carbon County, which petition was duly signed by at least ten percent (10%) of the electors of the county as determined by the number of votes cast at the last general election; and,

WHEREAS, the said petition was accepted by the said Board of County Commissioners and the proposition to impose a one percent (1%) tax, as authorized by the Wyoming Legislature, was placed for vote before the electors of Carbon County at the general election held on November 8, 1976; and,

WHEREAS, the proposition to impose a one percent (1%) tax upon retail sales of tangible personal property and other transactions set forth in Section 39-291 of the Wyoming Statutes (1957), as amended, was duly approved by a majority of the qualified electors casting their ballots;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF CARBON COUNTY, STATE OF WYOMING:

SECTION I

This ordinance shall be known, and may be cited as the Carbon County Sales Tax Ordinance.

SECTION II

That within the boundaries of Carbon County, Wyoming, there is hereby imposed and levied, and there shall be collected and paid, an excise tax upon every retail sale of tangible personal property and all those other transactions set forth in Section 39-291 of the Wyoming Statutes (1957), as amended, at the rate of one percent (1%) of the consideration paid or charged.

SECTION III

That the provisions of the tax hereby imposed shall be identical to those contained in Sections 31-287 39-290 through 39-304, 39-307, and 39-308 of the Wyoming Statutes, (1957), as amended, insofar as they relate to sales tax, except that the County of Carbon shall be the taxing agency, and an additional license to engage in business shall not be required if one has been or is issued to the wholesaler, retailer or proprietor under Section 39-290 of the Wyoming Statutes, as amended.

SECTION IV

All amendments enacted subsequent to the effective date of the legislative enactments of the statutory sections hereinabove set forth in Section III, relating to sales tax and not inconsistent with this ordinance shall automatically become a part of the Carbon County Sales Tax Ordinance.

SECTION V

The tax herein ordained and imposed shall not include the amount of any sales tax or use tax imposed by the State of Wyoming.

SECTION VI

The County of Carbon shall contract prior to the effective date of the county sales tax ordinance with the State Tax Commission to perform all functions incident to the administration or operation of the sales tax ordinance of the County of Carbon.

SECTION VII

This Ordinance shall be in force and tax effect at the hour of 12:01 o'clock, a.m. on the 1st day of December, 1977, and continue thereafter until otherwise repealed by vote according to the laws of the State of Wyoming.
