RIVERSIDE-ENCAMPMENT FIRE DEPARTMENT

Ron Martin, Encampment-Riverside Fire Chief, discussed with the Commissioners the possibility of helping to update their fire equipment since they also help fight County fires. Matching funds for a firetruck will be considered in the 1977-1978 County budget.

SHIRLEY BASIN LAW ENFORCEMENT

A delegation of citizens from Shirley Basin requested additional law enforcement protection for Shirley Basin. The Commissioners agreed to provide one more part time Deputy Sheriff in addition to the Deputy now serving on a part time basis. The two Deputies would arrange their time to be available for twenty-four hour law enforcement coverage.

CARBON COUNTY AGING SERVICE

Evelyn Mincer reported to the Commissioners the activities and the growing service provided by the Aging Service. The service is showing steady growth in all communities in Carbon County. She also presented a Narrative For Application For Nutritive Project Award under title VII of the Older American Act for 1977-1978 funding. Narrative is on file in the office of the County Clerk

CARBON COUNTY AGING SERVICE BOARD

The Commissioners accepted the resignation of Board member Jeanette Fisher of Medicine Bow, effective May 3, 1977. Cora Ellis, Medicine Bow was appointed to the Board to fill the unexpired term of Jeanette Fisher; her term being May 3, 1977 to March 4, 1979.

CARBON COUNTY MENTAL HEALTH

SHERIFF'S OFFICE - FURNISHING NEW ADDITION

Bids for furnishings for the new addition for the Carbon County Sheriff's Office were opened. The following firms submitted bids: Rawlins Newspapers, Inc., Rawlins, \$11,416.15; Horizon Printing & Stationery, Rawlins, \$12,974.00; Mills Company, Sheridan, Wy, \$13,432.50. The bid of \$12,974.00, being the second lowest bid, by Horizon Printing and Stationery, was approved. The low bidder, Rawlins Newspapers, Inc., did not meet specifications.
