The Board resumed its session, Glode and McMahon present; Glode, Chairman.

CARBON COUNTY PLANNING AND ZONING COMMISSION

Motion was made by Commissioner McMahon, and seconded by Commissioner Lemich and unanimously carried to approve the petition of Roland Murphy, Rawlins, Wyoming for a Zone Change from RAM to HB to allow future construction of automotive dealership facility, known as the Merendino-Murphy tract. The site consists of approximately 6.024 acres, located approximately $\frac{1}{4}$ mile north of Rawlins along Highway No. 287, legally described as SE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 4, Township 21N, Range 87W, Carbon County, Wyoming. Refer to Case File #78-16.

Motion was made by Commissioner McMahon and seconded by Commissioner Lemich and unanimously carried to approve the amendments to the Carbon County Zoning Resolution of 1972, specifically the following three items:

1. Section 461 - Procedure; Special Use Permit; Subsection 461.6 - The applicant shall pay a fee of \$25.00 to the Zoning Officer to cover the cost of the hearing notice and processing of the application.
2. Section 533-Zoning Permit Fees:

Up to and including \$1,000	\$ 10.00
More than \$1,000 up to and including \$10,000	\$ 20.00
More than \$10,000 up to and including \$25,000	\$ 30.00
More than \$25,000 up to and including \$50,000	\$ 40.00
More than \$50,000 up to and including \$100,000	\$ 50.00
More than \$100,000	\$100.00

3. Section 572-Application to Amend Resolution or Map; Subsection 572.1 - An application to amend this Resolution or Map shall be submitted to the Board of County Commissioners and the Carbon County Planning and Zoning Commission for review and processing as outlined under General Procedures, Section 571. The applicant shall include a fee in the amount of \$50.00 to cover advertising and processing costs. Refer to Case File #78-1A.

It was moved by Commissioner McMahon, seconded by Commissioner Glode, and unanimously carried that said appointment be approved.

BIDS ON CULVERTS

Bids were submitted for culverts by Culverts and Industrial Supply Company and Big "R" of Greeley, Inc. The Commissioners accepted the proposal from Culverts and Industrial Supply Company.

BIDS ON STORAGE TANK AND BOILER IN COURTHOUSE - HEATING SYSTEM

Bids were submitted for the removal of storage tank and boiler and replacement with water heater in the courthouse. The bids were submitted by Art's Plumbing and Heating Service and City Plumbing and Heating, Inc. The Commissioners accepted the proposal from Art's Plumbing and Heating Service.

RAWLINS SENIOR CITIZEN CENTER

An agreement was made the 8th day of June, 1978 between Carbon County Board of Commissioners, the Owner, and Dolence & Frullo, Inc., the Architect. It is the intention of the Owner to construct a Senior Citizen Center in Rawlins, Wyoming, hereinafter referred to as the Project.

CARBON COUNTY MEMORIAL HOSPITAL BOARD

CARBON COUNTY MUSEUM BOARD


The Board of County Commissioners reappointed Mrs. Epha Johnson to a three year term to commence July 6, 1978 and expire July 6, 1981.
