HANNA-CARBON COUNTY JOINT POWERS BOARD

Jim Haigler was appointed to the Hanna-Carbon County Joint Powers Board for a three (3) year term beginning November 8, 1978 to November 8, 1981, Emil T. Lemich term having expired November, 1978.

RAWLINS CARBON COUNTY AIRPORT

Motion was made by Lemich, seconded by McMahon and unanimously carried to adopt the following Resolution:

RESOLUTION

In order for the Federal Aviation Administration to consider the Rawlins-Carbon County Airport Board, Rawlins, Wyoming to become eligible to request the transfer of certain lands under Section 23 of the Airport and Airway Development Act of 1970, as amended, it is hereby resolved:

That the County of Carbon, Wyoming will enter into an ADAP grant agreement in cosponsorship with the City of Rawlins and the Rawlins-Carbon County Airport Board to perform airport development at the Rawlins-Carbon County Airport and that said land is needed for airport development.

That the County of Carbon hereby authorizes the Rawlins-Carbon County Airport Board to independently make application to the FAA for transfer of certain lands for a future airport development project for the Rawlins-Carbon County Airport under the Airport and Airway Development Act of 1970, as amended, and to make whatever assurances are necessary thereunder as contained in the grant agreements and other related documents.

That the County of Carbon does hereby covenant and agree that it will, together with the City of Rawlins, contribute funds to the extent necessary for the efficient and economical operation of the airport and related facilities and to take whatever further action is necessary to enable the Rawlins-Carbon County Airport Board to carry out its obligations under any grant agreements entered into as a cosponsor under the authority granted herein and by state statutes.

The County of Carbon does further covenant and agree that in their support of the Rawlins-Carbon County Airport Board, they will, in the event of dissolution of the Airport Board, or upon an FAA determination that said Airport Board is in noncompliance or default under the terms and conditions of a grant agreement for airport development, jointly and severally accept the responsibilities for such performance.
