DISTRICT BOUNDARY BOARD OF CARBON COUNTY

Joint Resolution and Written Proposal of the District Boundary Board of Sweetwater County, Wyoming, and the District Boundary Board of Carbon County, Wyoming, was introduced by Commissioner McMahon and read in full by Oscar Hall, County Attorney as follows:

A resolution and written proposal recommending an alteration and change of the boundaries affecting Sweetwater County School District One, State of Wyoming, and Carbon County School District One, State of Wyoming, in order to benefit the educational needs of the pupils by effectuating a more equitable division of assessed valuation based upon average daily membership, pursuant to the authority of Sections 21.1-136 through 21.1-150, Wyoming Statutes, 1957, as amended (Chapter 7, Wyoming Education Code of 1969, as amended).

WHEREAS, in its Decision and Order dated December 12, 1971, and in amendments thereto the State Committee on School District Organization, State of Wyoming, reorganized the following designated territory in School District No. 25, Bairoil, Sweetwater County, into Carbon County School District One, State of Wyoming:

Starting at the NE corner of Sweetwater County; thence south along the Carbon County-Sweetwater County line to the NE corner of the SE 1/4 of the NE 1/4 of Sec. 13, T26N R90W; thence west to the SW corner of the NW 1/4 of the NE 1/4 of Sec. 13, T26N R90W; thence north to the N 1/4 corner of Sec. 13, T26N R90W; thence west to the S 1/4 corner of Sec. 10, T26N R90W; thence north to the SE corner of NE 1/4 SW 1/4 Sec. 3, T26N R90W; thence east to the NE corner of SE 1/4 SE 1/4 Sec. 3, T26N R90W; thence north to the E 1/4 corner of Section 3, T26N R90W; thence west to the SE 1/4 corner of SW 1/4 NW 1/4 Sec. 3, T26N R90W; thence north to the NE corner of Lot 4, Sec. 3; thence east along the county boundary line to the NE corner of Sweetwater County, the point of beginning; and

WHEREAS, in 1977, the Ad Valorem Tax Division, Department of Revenue and Taxation, State of Wyoming, made an error by certifying that all of the assessed valuation in Township 26 North, Range 90 West, went to Carbon County School District One, instead of only that portion of assessed valuation attributable to the designated territory in School District No. 25, Bairoil, Sweetwater County, set for the above; and

WHEREAS, on December 5, 1977, a joint meeting of the Board of Trustees of Sweetwater County School District One and Carbon County School District One was held in Rock Springs, Wyoming, at which meeting were discussed the educational needs of the pupils, the error made by the Ad Valorem Tax Division, the financial needs of the school districts in view of the educational needs of the pupils, and the proposed transfer of all of Township 26 North, Range 90 West, from Sweetwater County School District One to Carbon County School District One, all of which is evidenced by a copy of the minutes of said meeting attached hereto and incorporated herein by this reference; and

WHEREAS, on December 13, 1977, Sweetwater County School District One notified Carbon County School District One that it was willing to make the proposed transfer of all of Township 26 North, Range 90 West, as previously discussed at their joint meeting; and

WHEREAS, both school districts are in agreement that the portion of the tax which was paid incorrectly by the Ad Valorem Tax Division to Carbon County in the 1977-78 school year would be returned to Sweetwater County in the 1978-79 school year; and

WHEREAS, by letter dated December 16, 1977, from Carbon County School District One to the respective district boundary boards, the request has been made that pursuant to the authority of Sections 21.1-136, through 21.1-150, Wyoming Statutes, 1957, as amended (Chapter 7, Wyoming Education Code of 1969, as amended), the respective district boundary boards take all necessary and proper action to approve and submit to the State Committee a written proposal recommending the aforesaid transfer of all of Township 26 North, Range 90 West; and

WHEREAS, proper notices have been given and publication of notices have been made, all in compliance with the requirements of Section 21.1-139, Wyoming Statutes, 1957, as amended; and

WHEREAS, the respective district boundary boards have considered the submissions of both school districts in question and have been fully advised in the premises; and

WHEREAS, the educational needs of the pupils have been fully considered as well as the manner in which the assets and debts of the school districts in question shall be allocated equitably; and

WHEREAS, from the above and foregoing considerations it is readily apparent that the proposed alteration and change of the boundaries of the school districts in question would be for the benefit of the educational needs of the pupils.

NOW, THEREFORE, BE IT RESOLVED:

1. It is the judgment of the respective district boundary boards that the following alteration and change of the boundaries of Sweetwater County School District One and Carbon County School District One be made as it would be for the benefit of the educational needs of the pupils:

The transfer from Sweetwater County School District One to Carbon County School District One of all that remaining portion of territory of Township 26 West, Range 90 North, Sweetwater County, Wyoming, which was not originally set over to said Carbon County School District One by the Decision and Order of the State Committee dated December 12, 1971, and amendments thereto.

2. The new metes and bounds legal descriptions of the affected school districts are as follows:

a. Sweetwater County School District One: all that territory previously designated as being in said school district less all of Township 26 North, Range 90 West, Sweetwater County, Wyoming.

b. Carbon County School District One: all that territory previously designated as being in said school district plus all of Township 26 North, Range 90 West, Sweetwater County, Wyoming.

3. The only affected trustee residence area is the designated territory in former School District No. 25, Bairoil, Sweetwater County, which was included in Carbon County School District One by the Decision and Order of the State Committee dated December 12, 1971, and amendments thereto; that trustee residence area will now encompass all of Township 26 North, Range 90 West, Sweetwater County, Wyoming.

4. The assessed valuation of the affected school districts shall be:

a. Sweetwater County School District One: \$312,996,145.00 (as of July 1, 1977)

b. Carbon County School District One: \$106,958,832.00 (as of July 1, 1977).

5. The assessed valuation per pupil ADM shall be:

a. Sweetwater County School District One: \$68,685.00 (as of September, 1977).

b. Carbon County School District One: \$41,689.00 (as of September, 1977).

6. The availability date for new assessed valuations for the fiscal year 1978-79 shall be on or about July 1, 1978.

7. Assets and debts of the territory to be transferred (the remaining portion of Township 26 North, Range 90 West, Sweetwater County, Wyoming, not originally set over to Carbon County School District One by the Decision and Order of the State Committee dated December 12, 1971, and amendments thereto) shall be allocated in the following manner:

a. The territory to be transferred shall remain liable for all bonded indebtedness of Sweetwater County School District One incurred up to the effective date of the proposed transfer. After said bonded indebtedness shall have been satisfied, said territory shall not be liable for any debts of Sweetwater County School District One.

b. In order to correct the error made in 1977 by the Ad Valorem Tax Division, Carbon County School District One shall return to Sweetwater County School District One in the fiscal year 1978-79 that portion of the tax which was paid incorrectly by the Ad Valorem Tax Division to Carbon County School District One in the fiscal year 1977-78, which tax is in the amount of \$224,000.00 as certified by the Ad Valorem Tax Division as evidenced by its letter dated December 22, 1977, to Carbon County School District One, a copy of which is attached hereto.

c. Except for the adjustments referred to in subparagraphs a and b hereof, all assets of the territory to be transferred shall be allocated to Carbon County School District One.

8. Liability of the respective school districts for bonded indebtedness incurred up to the effective date of the proposed transfer shall not change or be affected by this transfer. Of course, the territory to be transferred shall not be liable to any bonded indebtedness of Carbon County School District One existing on the effective date of the proposed transfer.

9. The respective district boundary boards reserve the right to meet on a date in the future for further reconsideration for the purpose of equalization.

10. This written proposal shall forthwith be submitted to the State Committee for consideration at its meeting on January 26, 1978.

URANIUM SUPPLY SERVICES CORP.

Representatives of Uranium Supply Services Corp. met with the Commissioners relative to a road relocation in Sections 2, 3, 10 and 11, T27N, R78W. Discussion was held concerning the expansion of a bridge which is in an area that floods regularly, washing that portion of said road. Action will be taken to correct this problem by the County and U.S.S. Corp. ROAD

Thereupon, the Board adjourned until the following day.

The Board resumed its session; all members were present.

APPEAL OF DECISION TO GRANT SPECIAL USE PERMIT TO UNITED CAMPGROUND, INC.

The Appeal of certain residents of the Ft. Steele area with reference to action taken by the Planning and Zoning Commission of Carbon County, Wyoming was heard by the Board of County Commissioners at 10:00 o'clock A.M. on January 4, 1978.

Mr. Teixeira applied for a Special Use Permit for a mobile home park on Lot 1, Section 26, T21N, R85W, 6th P.M. in Carbon County, Wyoming. The Planning and Zoning Commission voted to approve the Petition for a Special Use Permit.

Appeals of the Planning and Zoning Commission action were made in writing to the Board of County Commissioners, and the Board of County Commissioners held the hearing in the same manner as prescribed for the Planning and Zoning Commission on Special Use Permits. The Board of County Commissioners made the following determinations at the review hearing:

- A. The proposed use shall serve an obvious public need.
- B. The proposed use shall not be detrimental to the surrounding area or to established uses.
- C. That adequate and safe access and circulation shall be provided.
- D. That any resulting commercial and truck traffic shall not use a residential street nor create a hazard to developed residential area.
- E. That the applicant has taken adequate steps to minimize and control potential and environmental problems which may be resulting from the proposed use.

The Board then went into deliberation of the Appeal of Case File No. XI-77-103 from the Planning Commission. After consideration of the record evidence, testimony of the witnesses and the argument of Counsel, the Board unanimously affirmed the decision of the Planning Commission. The Board also by unanimous vote authorized and empowered the County Attorney to prepare a written decision to be signed by the Board.

COUNTY ROAD 401

Motion was made by Lemich, seconded by McMahon, and unanimously carried that the Board make application to the Bureau of Land Management for a Right-of-Way 100 ft. in width for change of County Road 401, running through Sec. 6, T16N, R87W, and Sec. 31, T17N, R87W. ROAD

MUTUAL RELEASE H.S.R.I.

Discussion was held by the Board and Lynn Davis of the Health Systems Research Institute, a non-profit corporation of Salt Lake City, Utah, relative to mutual claims and demands by each against the other relating to contractual relations of the parties from the inception thereof up to and including January 4, 1978. It was agreed that the sum of \$71,333.94 represented a full and complete adjustment of all claims arising by reason of said contractual relations. It was moved by Commissioner Lemich and seconded by Commissioner McMahon that the sum of \$71,333.94 be paid to H.S.R.I. in consideration of a mutual release in writing by the parties. Upon roll call, the vote was: Lemich, yes; McMahon, yes; Glode yes. It was further moved by Commissioner McMahon & seconded by Commissioner Lemich that a mutual release be executed and delivered by the parties. Upon roll call the vote was: Lemich, yes; McMahon, yes; Glode, yes. The Mutual release is on file in the office of the County Clerk.

Members of the Hospital Board of Trustees and Attorney Mike Golden were present to discuss with the Commissioners a proposed contract with Hospital Affiliates International. The Commissioners took the matter under advisement.

CARBON COUNTY PLANNING & ZONING COMMISSION

The Commissioners appointed B. G. "Jerry" Michie to fill the vacancy created on the County Planning & Zoning Commission when Gene McMillen's term expired. Jerry Michie will serve from 1/4/78 to 12/4/82.

BAGGS SOLID WASTE DISPOSAL DISTRICT BOARD

The Commissioners reappointed Mildred L. Marshall to another 3 year term on the Board of Trustees of the Baggs Solid Waste Disposal District. Her term will be from 1/4/78 to 9/8/80.

PROPOSED CHANGES IN ELECTION DISTRICT BOUNDARIES


