CARBON COUNTY PLANNING AND ZONING

A motion was made by Commissioner McMahon, seconded by Commissioner Lemich, and unanimously carried to adopt the following resolution:

A RESOLUTION ADOPTING THE LAND USE PLAN FOR  
CARBON COUNTY, WYOMING, AS DEPICTED BY THE  
ATTACHED MAP AND TEXT

WHEREAS, the Carbon County Commissioners authorized the Carbon County Council of Governments to undertake a Land Use Study of future growth and development of the Carbon County area; and

WHEREAS, it is desirable that there be a plan to help guide the growth and development of Carbon County in order to enhance our living environment; and

WHEREAS, the LAND USE PLAN of Carbon County is intended to provide broad general guidelines for the development of land within the planned areas; and

WHEREAS, the LAND USE PLAN for Carbon County is not intended to be a specific zoning plan; and

WHEREAS, the PLAN is not static and must be reviewed from time to time; and

WHEREAS, the County Commissioners have conducted public hearings on the PLAN and have considered citizens' comments relating to the PLAN,

NOW THEREFORE, BE IT RESOLVED that the Carbon County Commissioners hereby adopt the LAND USE PLAN for Carbon County as contained in the attached text and depicted by the attached map.

IT IS FURTHER RESOLVED that the citizens of Carbon County are hereby urged to acquaint themselves with the PLAN.

CARBON COUNTY SENIOR SERVICES, BOARD OF DIRECTORS

STATE REGISTRAR

Dr. D. Klein was appointed State Registrar of Birth and Death records for Carbon County by the State Division of Health and Medical Services.

PUBLIC HEALTH NURSE

Public Health Nurse Sherrie Patch was present to discuss with the Commissioners government regulations on architectural barriers to the handicapped. As it stands now, people in wheelchairs or on crutches can't get into the Health Office. Various remedies were discussed including a gliding chair lift, a ramp, or possibly a change of location into the new Senior Services Center when it is completed.

COMMISSIONER'S DEED

The property described as follows was deeded to Maggie Johns of Rawlins, Wyoming for the sum of \$1,466.30:  
S½ of Lot 15, Block 45, Union Pacific Fourth Addition to the City of Rawlins.

HIGHLAND PARK - SARATOGA

The Board of County Commissioners approved the plat for Highland Park to the town of Saratoga, located in the NE¼ SE¼ Sec 14, T17N, R84W, 6th P.M., County of Carbon. The plat provides that block numbered 36 of the Highlands Addition to the Town of Saratoga be designated as a park.

BOARD OF PRISONERS

APPOINTMENT OF DEPUTY COUNTY CORONER

Motion was made by Commissioner McMahon, Seconded by Commissioner Lemich and unanimously carried to approve the appointment of Daniel B. Whitted as Deputy County Coroner.

ORDINANCE NO. 1 -- WEIGHT LIMITS ON COUNTY ROADS

Motion was made by Commissioner McMahon that Ordinance No. 1 be introduced and read in full.

AN ORDINANCE OF THE COUNTY OF CARBON, STATE OF WYOMING ESTABLISHING WEIGHT LIMITS OF VEHICLES AND LOADS UPON ALL COUNTY ROADS IN CARBON COUNTY WYOMING.

WHEREAS, established county roads have road conditions which require that weight limits of vehicles and loads on said county roads be established,

WHEREAS, pursuant to such authority proper notice should be given to prevent unnecessary wear and tear on the roads of the county and the elimination of unnecessary traffic hazards and loss of life and property resulting from such traffic hazards, caused by the unregulated use of the roads of the county by certain types of motor vehicles.

NOW, THEREFORE, BE IT ORDAINED by the Board of County Commissioners of Carbon County, Wyoming, that the following be enacted:

Section 1. Authority

This ordinance is adopted pursuant to Section 24-1-104, Wyoming Statutes, 1977.

Section 2. Purpose

The purpose of this ordinance is the prevention of the unnecessary wear and tear on the roads of Carbon County in the elimination of unnecessary traffic hazards and loss of life and property and unregulated and unrestricted use of all county roads in Carbon County by trucks and motor vehicles.

Section 3. Weight restrictions

No vehicle shall be operated by any person, association or corporation on a county road of Carbon County, Wyoming, which exceeds the weight limitations prescribed for primary and secondary highways of the State of Wyoming pursuant to Section 31-5-1002(a), (viii), Wyoming Statutes, 1977, and based on the method of measurements therein stated or at a greater weight limitation as otherwise posted by sign on the road or bridge. Such Section is hereby adopted by reference and incorporated herein and expressly made a part hereof.

Section 4. Applicability of article

The terms of this Ordinance shall only be construed to apply to county roads duly established.

Section 5. Penalty

The provisions of Section 31-5-1005, Wyoming Statutes, 1977 are incorporated herein and expressly made a part hereof for purpose of establishing a penalty for exceeding load limits on county roads.

Section 6. Size and weight limits

For the purpose of uniformity, Section 31-5-1002(a), (viii), Wyoming Statutes, 1977 are incorporated by reference herein and expressly made a part hereof. Where not inconsistent and where appropriate the word "County" is substituted for the word "State".

Section 7. County Clerk

Said Wyoming Statutes shall be kept on file for examination in the office of the County Clerk of Carbon County, Wyoming.

Section 8. Emergency and Effective Date

The Board of County Commissioners of Carbon County deems that an emergency exists and this Ordinance shall be in full force and effect from and after passage and publication.
