1978 CARBON COUNTY DEPOSITORY

The Board of County Commissioners named the Wyoming Bank of Rawlins, Third & Buffalo, Rawlins, Wyoming as a public depository for Carbon County for the year 1978.

SHIRLEY BASIN ACCESS ROAD

R E S O L U T I O N

WHEREAS, the Board of County Commissioners of Carbon County wish to utilize the provisions of Section 24-69.1, Wyoming Statutes 1957, as Amended, 1967, by cooperating with the Wyoming State Highway Commission in the construction or the improvement of a county road, the extent and location of work which is as follows:

Reshaping existing roadway, 4" crushed gravel, 2" plant mix pavement and miscellaneous work on the Shirley Basin Access Road, beginning at the Jct. with Wyoming 487, thence easterly for approximately 1.1 miles to the Shirley Basin Townsite.

NOTE: Preliminary Engineering is being accomplished by project SC-CFM 6-23.

NOW, THEREFORE, be it resolved:

THAT the Board enter into a written agreement with Wyoming State Highway Commission covering said construction or improvement in accordance with the agreement attached hereto which is hereby approved and ordered filed in the office of the County Clerk of this county; that a majority of the Board and County Clerk of the county be, and they are hereby authorized and directed to execute the agreement on behalf of the Board.

PUBLIC DEFENDERS

The firm of MacPherson, Golden and Brown, Public Defenders, notified the Commissioners that they will not be renewing their contract with the County which expires June 30, 1978. The Public Defender Act, 1977, has appropriated funding to establish and staff public defender districts.

PLANNING AND ZONING

Members of the Carbon County Industrial Association met with the Commissioners for the purpose of supporting the funding of the Carbon County Planning and Zoning and the Council of Governments. They were in agreement that planning in Carbon County is essential.

SARATOGA MEDICAL CLINIC

Saratoga Mayor Kathy Glode was in attendance to request aid for construction of a new medical building suitable to house three physicians and the nurse practitioner. The Town has applied for a \$190,000.00 grant from the State Farm Loan Board and wants an expression of support from the County. The Commissioners agreed to send a letter expressing support for the plan and \$20,000.00 in aid. The Town of Saratoga is to donate the land.

OLD BALDY SEVENTH ADDITION

Motion was made by Commissioner Lemich, seconded by Commissioner McMahon and unanimously carried to approve the vacation of all lots in Blocks 11 through 17 of the Old Baldy Village Seventh Addition to the town of Saratoga.

COUNTY ROAD 291

It was regularly moved, seconded and unanimously carried that the request of Arch Mineral Corp. Seminoe No. 2, Box 530, Hanna, Wyoming for relocation of County Rd. No. 291 in Sec. 4 & 9, T22N, R81W, of 6th P.M. be approved and the County Attorney is authorized to do any and all things necessary to effect such change.

DOCTOR RECRUITING

The Commissioner's approved the agreements between Memorial Hospital of Carbon County and the following doctor's: Alla V. K. Reddy, and Robert K. York. As per agreement by and between Dr. Jeffrey R. Balison and Carbon County Memorial Hospital, Dr. Balison made repayment in the amount of \$17,280.00 to the Carbon County General Fund. All obligations are now fulfilled and the contract is completed.

CARBON COUNTY MEMORIAL HOSPITAL

The Board agreed to pay \$60,000.00 for new Tomography equipment for the Hospital, and agreed to purchase \$15,000.00 worth of orthopedic equipment. They expressed their intention of eventually having 9 ambulances to serve Carbon County.

RECREATION

The Board of County Commissioners gave permission to use the County property east of Harshman Street as a Softball practice area.

SIERRA MADRE SUBDIVISION

The Board of County Commissioners approved the plat for Sierra Madre Subdivision located in part of Section 20, 21, 28 and 29, T14N, R85W, of the 6th P.M., Carbon County, Wyoming.

LAND EXCHANGE

It was regularly moved, seconded and unanimously carried by the Board that the land exchange between the University of Michigan and the U. S. Dept. of Agriculture, Forest Service, be approved. The Forest Service will acquire 68.7 acres from the University of Michigan located in Sections 5, 6, 7 & 8, T12N, R81W of the 6th P.M., Carbon County Wyoming in exchange for 5 acres of land in Teton County located adjacent to Camp Davis which is owned and operated by the University of Michigan.

There being no further business, the meeting was adjourned.
