## CARBON COUNTY PLANNING &amp; ZONING

A motion was made by McMahon and seconded by Lemich and unanimously carried to allow the petition of Matthew Beebe, Fort Steele, Wyoming, for a zone change from R.A.M. (Ranching, Agriculture and Mining) to RD-5 (Residential Development). Site consists of 5.22 acres located south of Highway 1-80 and west of the North Platte River, Fort Steele, Wyoming, and is legally described as a portion of the S $\frac{1}{2}$ NE $\frac{1}{4}$  Section 35, Township 21N, Range 85W of the 6th P.M., Carbon County, Wyoming. (Case File No. 79-02.)

A motion was made by Lemich and seconded by McMahon to allow the petition initiated by the Carbon County Planning Commission for a zone change from R.A.M. (Ranching, Agriculture and Mining) to I (Industrial) on the entire length of Union Pacific Railroad rights-of-way as it extends through the unincorporated land of Carbon County. (Case File No. 79-01.)

A motion was made by McMahon and seconded by Lemich to amend the Carbon County Zoning Resolution of 1972 to add item 371.4 to read: 371.4: Any use for railroad transportation purposes. Use for a railroad transportation purpose shall include, but shall not be limited to, railroad tracks (including industrial and spur tracks) and related operating, maintenance and repair facilities (including bridges, supply warehouses, fueling facilities, loading or unloading ramps, cranes, yards, communication and signal systems, shops and other maintenance facilities. ## HUMAN SERVICE PROGRAMS

Marian Patchen, director of the Rawlins Head Start Development Center, explained the funding for Human Service Programs with regards to the Development Disabilities - children. Funding to be through the Wyoming Department of Health & Social Services with the County matching 10% of certain specified State funds.

The Commissioners also addressed the problem of mental health and substance abuse by requesting a County Government contract with the State for the purpose of providing mental health and substance abuse services for the citizens of Carbon County.

## MEDICINE BOW TASK FORCE

## KAISER AND COMPANY

Raymond E. Newman, Executive Vice President of Kaiser & Company, Municipal Bond Consultants/Underwriters, presented an outline of their Professional Consultant Services for the proposed Bond Election to be held in Carbon County to renovate the old Jr. High building and build the fairground stadium.

A special meeting was called for May 15, 1979 at 1:30 to finalize details concerning the bond issue.

## SARATOGA MEDICAL CLINIC

A delegation of Saratoga citizens interested in building a privately owned clinic in Saratoga with a County or City owned ambulance and x-ray section, met with the Commissioners to discuss financing of the public owned section. No action was taken.

## SWANSON BROTHERS

The Swanson Brothers met with the Commissioners concerning the abandonment or relocation of County Road 385. The road runs through a planned Saratoga sub-division. Thomas Smith, Attorney for Swanson Brothers and K. Craig Williams, Carbon County Attorney, are to determine the legal procedures to resolve this matter.
