The Board of County Commissioners met May 15, 1979 at 1:30 P.M., Grieve, present; McMahon, present; Lemich, present; Grieve, Chairman.

A special meeting of the Board of County Commissioners (herein sometimes designated as the "Board") of the County of Carbon, State of Wyoming, was held at the regular meeting place of the Board of the County Courthouse in Rawlins, Wyoming, in said County, on Tuesday, the 15th day of May, 1979, at the hour of 1:30 P.M., pursuant to notice and call duly given to each member of the Board.

The meeting was called to order by the Chairman of the Board, and upon roll call the following members were found to be present, constituting a quorum:

Thereupon, the following proceedings, among others, were had and taken:

Commissioner Martin McMahon introduced the following resolution, which was read in full and is as follows:

RESOLUTION

WHEREAS, The County of Carbon (the "County") in the State of Wyoming, is duly organized and existing under the Constitution and laws of the State of Wyoming; and

WHEREAS, the Board of County Commissioners of the County (herein "Board") has determined that it is necessary and for the best interests of the County and its inhabitants that the County together with Carbon County School District No. 1 establish, purchase, construct and equip joint public school and County courthouse and administrative office facilities, including a library (the "Joint Facilities Proposal"); and

WHEREAS, The Board has determined that it is necessary and for the best interest of the County and its inhabitants that the County construct, improve and equip county fairgrounds including a community stadium building thereon (the "Fairground Proposal"); and

WHEREAS, there are not sufficient funds in the treasury of the County available for such purposes; and

WHEREAS, the Board deems it necessary and advisable that a bonded indebtedness be contracted in the aggregate principal amount of not to exceed \$2,600,000.00 for the Joint Facilities Proposal, and of not to exceed \$1,500,000.00 for the Fairground Proposal; and

WHEREAS, the laws of the State of Wyoming empower the Board, whenever a majority thereof so decide, to submit to the electors of the County the question of whether the Board shall be authorized to issue the registered coupon bonds of the County for said purposes; and

WHEREAS, said laws and Chapter 21, Title 22, W.S. 1977, as amended (the "Political Subdivision Bond Election Law"), in effect provide that whenever a municipality, including the County, proposes to issue general obligation bonds, the bond question for the bond issue shall be submitted to a vote of the qualified electors of the municipality at any regular election held therein or at a special election called for that purpose and of a majority of the ballots cast as provided in the Bond Election Act is in favor of the issuance of the bonds, the proposal to issue them shall have carried; and

WHEREAS, the Board desires to submit to electors of the County the question of whether the Board shall be authorized to issue the registered coupon bonds of the County for the Joint Facilities Proposal and for the Fairground Proposal.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF CARBON COUNTY, STATE OF WYOMING:

Section 1. Ratification. That all action heretofore taken (not inconsistent with the provisions of this resolution) by the Board and the officers of the County, directed toward the Joint Facilities Proposal and the Fairground Proposal, and the issuance of its registered coupon bonds for that purpose is hereby ratified, approved and confirmed, including without limiting the generality of the foregoing, authorizing the issuance of the bonds at an election and giving notice thereof.

Section 2. Bond Election. A County bond election is hereby designated, ordered and called to be held in the County on Tuesday, the 10th day of July, 1979 (the "bond election" or the "election"), at which there shall be submitted to the qualified electors of the County the bond questions set forth in Section 6 of this resolution.

Section 3. Qualifications of Electors. No person shall be permitted or qualified to vote at the bond election who is not a qualified elector. The term "qualified elector" includes every citizen of the United States who is a bona fide resident of the State of Wyoming and the County of Carbon, has registered to vote therein and will be at least 18 years of age on the day of the election. No person is a qualified elector who is a mentally incompetent person, or who has been convicted of a felony and his civil rights have not been restored. A literacy test shall not be imposed

as a condition to voting in any election.

No person shall vote whose name does not appear on the official registry list for the precinct in which he offers to vote. Provided, however, members of the armed forces or merchant marine of the United States and citizens of the United States and of Wyoming who have been temporarily residing outside the United States and the District of Columbia and their spouses and dependents who are eligible to register and qualified to vote and who have been discharged from the armed forces or who have terminated their service or employment too late to register at the time and place where registration is required, shall be entitled to register for the purpose of voting at such election. Absentee registration and the use of the federal postcard prescribed by the Federal Voting Assistance Act of 1955, shall be permitted pursuant to Section 22-3-117, W.S. 1977.

Section 4. Notice of Registration. The County Clerk is hereby requested to give notice concerning registration by causing a printed notice of registration to be published in English and Spanish in each legal newspaper of general circulation in the County. Said notice of registration shall be published at least 40 days before said election. Said notice shall be in substantially the following form:

PUBLIC NOTICE IS HEREBY GIVEN that the registration list to be used in connection with a bond election for Carbon County, Wyoming, to be held on Tuesday, July 10, 1979, shall contain the names of electors whose names appear on the registry lists at the close of business of the office of the County Clerk of Carbon County, Wyoming, on June 9, 1979.

Any qualified elector of the County who is not now registered and who wishes to vote at the bond election may register on or before June 9, 1979, at the office of the Carbon County Clerk at the County Courthouse in Rawlins, Wyoming, or at the office of any city or town clerk in the principal office building of each city or town in Carbon County, Wyoming.

Section 5. Continuing Authority. The authority to issue the bonds if conferred at the election, shall be deemed a continuing authorization to issue and deliver the bonds at one time or from time to time, in one or more series, all as ordered by the Board. Except as otherwise provided by law, neither the ~~partial~~ exercise of the authority so conferred nor the lapse of time shall be considered as exhausting or limiting the full authority so conferred by the electors voting in favor of said bond question.

Section 6. Paper Ballots. Paper ballots shall be used at the election, and they shall be prepared and furnished by the County Clerk to the officers of election, to be by them furnished to the electors. Such ballots shall also be utilized by absent voters in accordance with the Wyoming Election Code of 1973. The ballots shall be printed in English and Spanish on white paper and shall be in substantially the following form:

Section 7. Manner of Holding Election. Said election shall be held in the manner prescribed by the Political Subdivision Bond Election Law, being Section 22-21-101 through 22-21-112, Wyoming Statutes 1977, and the Wyoming Election Code of 1973, as amended, and all other laws thereunto enabling.

Section 8. Hours of Voting. The polls shall be opened on the day of the election at 8:00 a.m., and shall remain open until and be closed at 7:00 p.m.

Section 9. Precincts and Polling Places. The precinct boundaries for said election shall be the same as established for the last general election, except that certain precincts shall be consolidated and vote at a single polling place as provided below. All of the judges and counting board must be registered electors of the precinct wherein appointed, and must be physically, morally and mentally competent to perform their duties. Before entering upon his duties each shall subscribe to the following oath in writing:

"I do solemnly swear (or affirm) that I will impartially and to the best of my knowledge and ability perform the duties of my office. I will studiously endeavor to prevent all frauds, deceit and abuse in the application of the election laws of this state."

The oath shall be taken before a judge of election.

Section 10. Absentee Voting. Any qualified elector who will be absent from his place of residence on election day, or who cannot be present at his precinct polling place on election day because of illness, injury, disability, old age, or tenets of his religion, may vote by absentee ballot upon making application in person, in writing, or by telephone, to the County Clerk for an absentee ballot, and by furnishing the following information: name in full, social security number and residence by street, city and county, and zip code; the election for which an absentee ballot is requested; a statement that the applicant is entitled to vote in the election; and if not obtained in person, the address to which the absentee ballot is to be mailed. Request for a ballot may be made on behalf of an absentee qualified elector if the prescribed information is furnished. Such absentee voter shall be entitled to vote upon executing an affidavit, hereby required to be made, before an official qualified to administer oaths or before two disinterested witnesses, such affidavit to be printed on the reverse side of the inner ballot envelope in red ink in substantially the following form:

A qualified elector may apply for an absentee ballot not more than 40 days prior to the election, and up to the day of the election.

Section 12. Canvass by Election Board. Immediately after the closing of the polls the election officers in each precinct shall proceed to canvass the votes cast on the bond questions. The results of the election on the bond questions disclosed by such canvass shall be certified by the election board of each voting precinct, and the election officers shall make their returns to the County Clerk. Thereupon the Board shall examine and canvass the ballots and declare the results of the bond election and cause a statement thereof to be entered on its records. If the majority of the ballots cast at the election favor the issuance of the bonds, the proposal shall have carried and the Board, in the manner provided by law, shall then proceed to declare the results of the bond election and complete the printing, execution, advertisement and sale of the bonds.

Section 13. Notification of County Clerk. Immediately after the adoption of this resolution, the Board shall cause a copy of the Proclamation and Notice of Bond Election contained in Section 11 hereof, which specifies the date of election and the bond questions, to be provided to the County Clerk of Carbon County, Wyoming, as written notification of said election.

Section 14. Authorization. The officers of the County are hereby authorized and directed to take all action necessary or appropriate to effectuate the provisions of this resolution.

Section 15. Repealer. All by-laws, resolutions, and parts of resolutions in conflict with this resolution are hereby repealed to the extent of any inconsistency herewith.

Section 16. Severability. If any section, paragraph, clause or provision of this resolution shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause or provision shall not affect any of the remaining provisions of this resolution.

Section 17. Emergency. That by reason of the urgent necessity of submitting the proposal to the electors of the County without delay, and it appearing that an emergency exists and the Board so finds and determines, this resolution shall be in full force and effect from and after its passage and approval.

WYOMING HUMAN SERVICES PROJECT

Members of the Wyoming Human Services Project, Head Start Child Development Center and Carbon County Counseling Center met with the Commissioners to discuss the Human Service needs in Carbon County.

A delegation from Saratoga met with the Commissioners to ask for County funding for the Saratoga Clinic. They asked that \$80,000.00 be appropriated and given to the Town of Saratoga to pay the total cost for a 1492 Square foot facility which would include an emergency or trauma room, an x-ray room, an ambulance entry and ambulance storage area. This cost would include the x-ray shielding for the x-ray room, paving for approximately 30 parking spaces, plus sidewalks and curbs.

This portion of the medical clinic plus this portion of the land will be owned by the Town of Saratoga. All maintainance, utilities, and insurance will be the responsibility of the Town of Saratoga. No action was taken at this meeting.

SWANSON BROTHERS SUBDIVISION PLAT

The Commissioners took under advisement a request from Thomas S. Smith, Attorney for Swanson Brothers, to consider one of the following procedures under the Wyoming Statutes to vacate County roads running thru the Swanson Brother Subdivision:

- (a) Advise the Commissioners that they no longer have jurisdiction over the roads, since the roads are within the city limits and are now clearly under the jurisdiction of the town council; whereupon the Commissioners could pass a motion denying jurisdiction.
- (b) Ask the Commissioners to adopt a motion agreeing to submit the roads to the jurisdiction of the town council, upon the recording of a final plat which dedicates new replacement streets to the public; thereby preserving the public interest in the public ways.

No approval was given to the above options by the Board of County Commissioners.

COUNTY ROADS, 503 and 401

A motion was made by Lemich and seconded by McMahon and unanimously carried to adopt the following resolution:

RESOLUTION

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS, CARBON COUNTY, WYOMING, that Carbon County make application to the United States Department of the Interior for legal authority to reroute a county road through portions of Section 6, Township 16 North, Range 87 West, and Section 31, Township 17 North, Range 87 West, as more fully set forth on the map setting forth such relocation attached to the application as Exhibit A and as legally described in Exhibit B.

BE IT FURTHER RESOLVED that Robert Grieve, as chairman of the Board of County

Commissioners of Carbon County, Wyoming, be authorized to execute any right-of-way documents on behalf of Carbon County, Wyoming.

BE IT FURTHER RESOLVED that the Board of County Commissioners of Carbon County, Wyoming, ratify and affirm all actions taken to commence this road rerouting and empower the appropriate county officials to take such actions as are necessary to accomplish this road rerouting.
