Case #79-09 - Zone Change - El Rancho Not So Grande, by John Crow, President, Box 1211, Saratoga, Wyoming - zone change from RAM (Ranching, Agriculture, & Mining) to RD-40 (Residential Development). Site is approximately 3 miles northeast of Saratoga, Wyoming, and is legally described as NE¼ SW¼ Section 30, Township 18N, Range 83W, Carbon County, Wyoming. No motion was made to move off the table.

Case #79-10 - Zone Change - Michael A. Jonas, Box 1222, Saratoga, Wyoming - zone change from RAM (Ranching, Agriculture, & Mining) to RD-10 (Residential Development). Site is approximately 2 miles south of Saratoga, Wyoming, along Spring Creek Road, and is legally described as SW¼ NW¼ Section 25, Township 17N, Range 84W, Carbon County, Wyoming. No motion was made to move off the table.

LITTLE SNAKE RIVER CONSERVATION DISTRICT

A Cooperative Agreement was entered into by and between Carbon County and the Little Snake River Conservation District.

Carbon County is a local agency of limited and prescribed jurisdiction, to be employed in administering the affairs of the State, and promoting the public welfare generally (WS Title 18).

The Little Snake River Conservation District is a subdivision of the State responsible for the conservation of soil, water and related natural resources in Carbon County (WS 11-16-101).

Because of the interrelationships between the public welfare and conservation programs this Agreement is developed for the purpose of formalizing working relationships between the signatory parties.

This Agreement is on file in the office of the County Clerk.
