CARBON COUNTY PLANNING AND ZONING

A motion was made by McMahon and seconded by Lemich and unanimously carried to allow two (2) delegates from the Carbon County Planning Board to attend the A.P.A. National Planning Conference in Miami, Florida, March 3rd thru March 8th.

An amendment to the Carbon County Zoning Resolution of 1972 was presented to the Commissioners.

Case File No. 78-5A was presented to the Commissioners. More specifically Section 500, Subsection 530 by adding to the first paragraph after the words "placement of structures" the following wording in parenthesis "(excluding dams, ditches, canals, water wells and fences)".

Amended paragraph would read: "Until such time that a "uniform building code" is adopted by the county, all construction that either places new buildings or structures on the land, or adds to the floor space of existing buildings either vertically or horizontally or that alters the physical appearance of the site by placement of structures (excluding dams, ditches, canals, water wells and fences) or physical improvements such as paving or lighting (if valued at more than \$500) shall require the submittal and approval of a zoning permit. New signing relocation or enlargement requires the submittal of a zoning permit regardless of value".

A motion was made by Lemich, seconded by McMahon and unanimously carried to Amend Section 500, Subsection 530.

A motion was made by Grieve, seconded by Lemich and unanimously carried to allow the Petition of Michelle J. Hunter, Box 1302, Saratoga, Wyoming, to change the zoning classification of 20 acres (m/l) from R.A.M. to RD-10, as per Section 324.1, Carbon County Zoning Resolution. Tract is located approximately 2 miles northeast of Saratoga, Wyoming, legally described as W½, NW¼, SE¼ Section 31, Township 18N, Range 83W, Carbon County, Wyoming.

The Commissioners instructed the Zoning & Planning Board to consider an Amendment to the Carbon County Zoning & Planning Resolution whereby persons petitioning for any zone change must have access to the property being re-zoned.

CITIES SERVICE GAS COMPANY

RESOLUTION

THIS INDENTURE, made this 19th day of Dec., A.D., 1978, by and between CARBON COUNTY, a political subdivision of the State of Wyoming, of the first part, and hereinafter called the first part, and Cities Service Gas Company, a corporation organized under the laws of Delaware, of the second part, hereinafter called the second party.

WITNESSETH: That the said party of the first part for and in consideration of the sum of ONE DOLLAR (\$1.00) to the said party of the first part in hand paid by the said party of the second part, the receipt of which is hereby confessed and acknowledged. has granted and does hereby grant and give to said second party the right and easement to construct, establish, lay down and maintain along, over and across all County roads, highways, streets, alleys and dedicated streets and rights of way therefor in Carbon County, Wyoming, a pipe line or lines for the purpose of transporting and conveying gas, petroleum or any of its products, together with the right of ingress, egress and regress to maintain, renew, reconstruct, replace, or substitute pipe of different size in place of that originally laid, and operate said pipe line or lines, with the right to remove the same at the pleasure of the second party. Said pipeline crossings are to be made as shown on the schedule attached and marked Exhibit "A".

The above rights and easements given and granted as aforesaid are on the express condition that all pipe or pipe lines constructed as aforesaid shall be constructed not less than thirty-six inches (36") below and in the clear of the flow line of any and all of the drainage ditches along said roads, highways, streets, alleys, dedicated streets or rights of way above mentioned.

Soils removed during the construction of said pipeline shall be replaced in the ditch and compacted to a minimum of 95% Proctor as determined by a qualified soils laboratory. Any settling that may take place where the pipeline ditch crosses a county road, shall be repaired by Cities Service Gas Company at their expense for a period of 2 years.

Further, that in the event the County roadways or highways as at present located and established, should be changed, rebuilt or repaved, second party will make all changes which said first party may deem necessary on account of changing of said rights of way or roadways

hereinbefore mentioned and referred to all at the expense of the second party, provided, however, that the rights or easements of the second party, as to improvements already made on, along or across said County roads or fights of way therefor shall remain unimpaired; that the second party shall at all times keep said rights of way, roadways or highways open for traffic and will replace and repair all road crossings and ditches in the same condition in which they were before any excavation or alteration, maintenance, laying, relaying, renewing and reconstruction of any of the improvements of the second party must be done subject to the satisfaction and approval of the first party, and that said second party will indemnify and hold harmless the State of Wyoming, the County of Carbon, the public or any private individual from and on account of any suits, claims, demands, executions or judgments which may ever come, be made or brought against said first party for or on account of the establishment of said improvements by said second party, as provided herein, and in the operation of said line or lines.

All of the rights, easements, terms, covenants and conditions hereinabove set forth shall inure to and be binding upon the legal representatives, successors and assigns of the parties hereto, and the right of assignment is hereby granted to said second party.

WYOMING HIGHWAY DEPARTMENT

A motion was made by Lemich and seconded by McMahon and unanimously carried to approve the plans and estimated engineering costs for State Project No. SC-CFM 6-25 Sheep Mountain Reservoir Draw, Little Sage and Miller Creek Carbon County.

Federal-Aid Safer Off-System Roads Program Project SOS-0601(3) involves providing matching funds for project S)S-0601(3), Sinclair-Seminole Road, beg. approx. 31.2 miles north of Sinclair, thence northerly for approx. 4.8 miles; and Project SC-CFM 6-25 involves preliminary engineering for survey and plan preparation for future construction involving roadbed preparation, placement of crushed base and inverted penetration surfacing on the Sinclair-Seminole Road, beg. approx. 31.2 mi. north of Sinclair, northerly for approx. 4.8 mi. Project SC-DFM 6-25 is providing the county matching funds. Both of the above projects were also approved by the Commissioners.

FAIR BOARD

Margaret Espy was reappointed for a five (5) year term commencing February 1, 1979 to February 1, 1984.

SARATOGA - CARBON COUNTY JOINT POWERS BOARD

L. C. FREEBURG was reappointed for a two (2) year term commencing February 1, 1979 to February 1, 1981.

BAGGS SOLID WASTE BOARD

Phil Weber was reappointed for a three (3) year term commencing September 8, 1979 to September 8, 1982.

SARATOGA LAND FILL

ROAD

Mayor Howard V. C. Davis, Saratoga, again came before the Board asking help from the Road and Bridge Department to build a road to the Saratoga Land Fill.

The Commissioners made no decision because the cost of maintaining county roads has been extremely high due to the severe winter conditions. All available men and equipment are being used on the county roads.

There being no further business, the meeting was adjourned until the following day.

February 7, 1979

The Board resumed its session, Commissioners Grieve, Lemich and McMahon present. Robert Grieve, Chairman.

BUREAU OF LAND MANAGEMENT

Al Spencer and Fred Wolfe from the Bureau of Land Management held a meeting with the Commissioners to discuss several B.L.M. programs in Carbon County. They pointed out seven (7) areas in Carbon County that are being considered for roadless areas. Environment studies of areas where coal will be mined and control of wild horses in Carbon County were also discussed. They also said the B.L.M. will work with the County on updating records pertaining to all roads in the County.

OLD JUNIOR HIGH BUILDING

The Commissioners discussed the progress that is being made towards acquiring the Old Junior High Building for use as County Office space. Alan Sundberg said that the cost of renovating the building would have to be determined before a bond issue could be presented to the voters. The Commissioners noted that the bond issue would have to pass before the County would accept the building from School District No. 1.

DEPARTMENT OF PUBLIC ASSISTANCE AND SOCIAL SERVICE

After July 1, 1979, the Commissioners and the Treasurer have agreed with SD-Pass to continue the reports and all services presently being done for EA/GA accounts. Funds would come directly to the Treasurer's Office from SD-Pass by warrant and disbursed to CD-Pass by the Treasurer.

JUSTICE OF THE PEACE - CARBON COUNTY

Notice was given January 9 & 16, 1979, that the Board of County Commissioners of Carbon County, Wyoming, would accept written applications for the position of Justice of the Peace at Medicine Bow, Dixon, Saratoga, Elk Mountain and Rawlins (2), until 10:00 A.M. January 24, 1979.

The qualifications for appointment to the Justice of the Peace positions for Medicine Bow, Dixon, Saratoga, and Elk Mountain shall be as follows:

A. Must reside within the municipality selected as a site of a Justice Court, provided that if the Board of County Commissioners finds extraordinary circumstances to exist which warrant an exception to the residence requirement it may present its findings, including an assurance that the Justice will be available as provided in subdivision (D) of this Rule, and appropriate request to the Supreme Court that an Order be granted allowing such exception.

B. Must be a qualified elector of the county.

C. Must be of good moral character and have a good reputation in the community.

D. Must be available and willing to perform the duties of a Justice at all times of the day or night.

E. Must agree to attend, and attend, the first available training school after election or appointment and each training school thereafter while in office, or be subject to disciplinary action.

F. Must agree to comply with all constitutional provisions, statutes, rules and regulations pertaining to the office of Justice of the Peace, and to submit such reports and data as required by the Supreme Court.

The qualifications for the positions in Rawlins shall be as set forth above, provided, that the Justices of the Peace in Rawlins shall also be authorized to practice law in the State of Wyoming. The election of Margie W. Meacham to one of the positions in Rawlins is hereby ratified and confirmed.

Such applications were filed with the office of the County Clerk, Courthouse Building, Rawlins, Wyoming.
