COMMISSIONER'S PROCEEDINGS

SPECIAL MEETING

The Board of County Commissioners met March 15, 1979 at 2:00 P.M.. Grieve, McMahon and Lemich present, Grieve, Chairman.

BIDS - SENIOR CITIZEN CENTER - RAWLINS

The meeting was called to order by Commissioner Grieve for the purpose of opening bids for the building of the Senior Citizen Center - Rawlins.

Three (3) sealed bids were opened and reviewed to see that they met legal specifications. The bids were read in five (5) items and unit prices. Total bids of the 5 items but not the unit prices were: L.M. Olson - Rawlins \$636,400.00, Groathouse Construction - Laramie \$612,600.00, Regulus Corporation - Green River \$814,631.00.

A motion was made by Lemich to take the bids under advisement and the motion was seconded by McMahon; roll was called with the following results; Grieve - aye, Lemich - aye, McMahon - aye.

COUNTY TREASURER

A motion was made by Lemich and seconded by McMahon to set the bond of Carbon County Treasurer at \$100,000.00. Roll was called with the following results; Grieve - aye, Lemich - aye and McMahon - aye.

CARBON COUNTY RETIREMENT

Commissioner Lemich moved that the present non-elected employees of Carbon County, Wyoming be given a 5.57% increase in pay effective March 1, 1979 and that the County no longer contribute the employee portion of the said non-elected employees contribution; the Elected officers salary and retirement contributions are to remain the same as set forth by Resolution dated May 15, 1978.

The motion was seconded by McMahon, roll was called with the following results; Grieve-aye, Lemich-aye, McMahon - aye.

A motion was made by McMahon that no County Employee may make a purchase for the County without a purchase order. Seconded by Lemich; roll was called with the following results; Grieve-aye, Lemich-aye, McMahon-aye.

PERSONNEL POLICY AND PRACTICES

A motion was made by Lemich that any employee who leaves his County position to take employment elsewhere loses seniority. The motion was seconded by McMahon; Roll was called with the following results; Grieve-aye, Lemich-aye, McMahon-aye.

COMPUTER ELECTION SYSTEMS - VOTOMATICS

The Commissioners reviewed the voting methods now being used by the County which are paper ballots and lever voting machines. Due to the rapid growth in the County and the need for more machines in some precincts and machines for precincts now using the paper ballots, the Commissioners agreed that one method of voting for all precincts should be used. A motion was made by McMahon to purchase Computer Election Systems Votomatics. The motion was seconded by Lemich; roll was called with the following results; Grieve-aye, Lemich-aye, McMahon-aye.

There being no further business, the meeting was adjourned
