CARBON COUNTY PLANNING & DEVELOPMENT

A motion was made by Lemich and seconded by McMahon to approve the following Resolution:

R E S O L U T I O N

WHEREAS, there has been a large increase in the number of injuries sustained by children and other persons from the use of fireworks in Carbon County, Wyoming, and

WHEREAS, danger constitutes a clear and compelling public danger,

NOW, THEREFORE, BE IT RESOLVED by the County Commissioners of Carbon County, Wyoming, as follows:

Section 1 - Definitions

A. "Fireworks" means and includes any article, devise or substance prepared for the primary purpose of producing a visual or auditory sensation by combustion, explosion, deflagration, or detonation, including, without limitation, the following articles and devices commonly known and used as fireworks: toy canons or toy canes in which explosives are used, blank cartridges, firecrackers, torpedoes, sky rockets, roman candles, any daygo bombs, soft shell firecrackers, exceeding 1/2 inch in length and 1/8 inch in diameter, sparklers, vesuvius fountains, spray fountains, torches, color fire cones, star and comet type aerial shells with or without explosive charge for the purpose of making a noise, and color wheels.

B. "Person" shall include an individual, partnership co-partnership, firm, company, association or corporation.

Section 2

It shall be unlawful for any person to offer for sale, expose for sale, sell, or give away any fireworks in Carbon County, Wyoming, at any time except between June 21 and July 5 of each year succeeding the passage of this Resolution.

Section 3

This Resolution shall be deemed an additional regulation upon the sale and use of fireworks in Carbon County, Wyoming, and in no way shall be construed to limit the State Statutes governing fireworks which otherwise apply.

Section 4

It shall be unlawful to sell fireworks in Carbon County, Wyoming, as permitted hereinabove, without first obtaining from the Board of County Commissioners, Carbon County, Wyoming, a permit for such sales. Such permits shall be issued by the Board of County Commissioners for a fee of Ten Dollars (\$10.00) to any person of good moral character that has a safe place of sale for the fireworks, that complies with the Carbon County Zoning Resolution and has been permitted by the Carbon County Zoning Administrator.

BUDGET HEARING

A motion was made by Lemich and seconded by McMahon and unanimously carried that the Budget Officer schedule a Public Hearing in late May with any Agency or County Office whose projected budget request exceeds 7% of last years budget expense.

SENIOR CITIZEN CENTER - BAGGS

A proposed building plan for the Senior Citizen Center of Baggs was presented to the Commissioners by Lloyd Fleming and Sid Weber. A decision was made that the County Surveyor would inspect the plans for the building and the Board would review the final bids.

VOCATIONAL REHABILITATION

A request for \$10,000.00 was made by representatives from Ark Industries and Rehabilitation Center for participation in a Vocational Rehabilitation Special Job Placement Project for Handicapped Citizens of Carbon County. The matter was taken under advisement.
