The following change orders were presented to the Commissioners for approval:

Powers Builders Supply, Bid Package No. 22, Specialties

ROCK CREEK VOLUNTEER FIRE ZONE

S. Beumee, H. Brokaw and J. Dobson came before the Commissioners seeking assistance in providing an additional pumper for Rock Creek Volunteer Fire Zone. It was suggested the Forestry Services of Wyoming be contacted for possible acquisition of equipment. The Fire Zone informed the Board that Marathon Oil in McFadden has offered to house the equipment. Each rancher is contributing \$100 per set of buildings, which should net about \$3,000. The upkeep could be handled thru monies received from the Forestry Service for fire calls. The matter was taken under advisement.

The possibility of contracting Mr. LaBeau for snow removal was re-discussed.

MEDICAL BUILDING

Jay Grabow requested the assistance of the Board in assuring leasing of a proposed Medical Building. He asked that the County assume responsibility of leasing two suites for two years and two suites for six months in the event doctors are not available to rent the space.

The Commissioners advised Mr. Grabow they cannot commit monies not budgeted.

CARBON COUNTY PLANNING & DEVELOPMENT

Public hearing was held before the Board of Commissioners on the following:

Case #80-14 - Variance - Curtis Rochelle, Hidden Valley Estates, P.O. Box 996, Rawlins, Wy. 82301 - an application for a variance to Section 5.08 of the Carbon County Zoning Regulations to permit the development of one-acre lots without having to supply either water distribution or sewage collection. Site is legally described as NE $\frac{1}{4}$, Pt. NW $\frac{1}{4}$, SW $\frac{1}{4}$ Section 25; Pt. SE $\frac{1}{4}$ Section 24, Township 17N, Range 88W, Carbon County, Wyoming. Roll was called with the following results: Grieve, Aye; McMahon, Aye; Lemich, Abstain.

Case #80-15 - Re-Plat - Curtis Rochelle, Hidden Valley Estates, P.O. Box 996, Rawlins, Wy. 82301 - A replat to provide for the addition of approximately thirty one-acre lots to the original Final Plat which was approved by the Board of County Commissioners on June 6, 1978. Site is legally described as NE $\frac{1}{4}$, Pt. NW $\frac{1}{4}$, SW $\frac{1}{4}$ Section 25; Pt. SE $\frac{1}{4}$ Section 24, Township 17N, Range 88W, Carbon County, Wyoming. No Action Taken.

Case #80-16 - Zone Change - Pat Lynch, P.O. Box 455, Encampment, Wy. 82325 - zone change from RAM (Ranching, Agriculture & Mining) to RD-40 (Residential Development) to allow for the construction of one residence on the 25.09 acre parcel of land. Site is located approximately 12 miles southeast of Encampment on the Trowbridge Ranch and is legally described as SW $\frac{1}{4}$, Section 20 and NW $\frac{1}{4}$ Section 29, Township 14N, Range 82W, Carbon County, Wy. Roll was called with the following results: Grieve, Aye; McMahon, Aye; Lemich, Aye.

COUNTY ROAD # 347

An overweight Permit, No. 35, was granted to Lawrence Bustos, Rural Route, Ft. Steele, Wy., on County Road #347, approximately 2 miles North from the Ft. Steele Interchange, SW $\frac{1}{4}$, Section 26, Township 21N, Range 85W.

MEDICINE BOW MEDICAL CLINIC

A group of citizens from Medicine Bow discussed the possibility of purchasing a modular building from the County of Sweetwater to be used as a Medical Clinic in Medicine Bow. The Union Pacific Railroad Company has made a commitment to the project for land and equipment. A motion was made by McMahon, seconded by Lemich and unanimously carried to purchase the building from Sweetwater County for \$21,000. provided specifications qualify.

CIVIL DEFENSE COORDINATOR

Allen Bergstrand presented a proposal to act as Civil Defense Coordinator for the County under a contract rather than as a County Employee. A motion was made by McMahon to accept the agreement which was seconded by Lemich. The roll was called with the following results: Grieve, Aye; Lemich, Aye; McMahon, Aye.

AGREEMENT

THIS AGREEMENT, Made and entered into this date, by and between Carbon County, Wyoming, a body politic and corporate, hereinafter referred to as "Carbon County" and Allen Bergstrand.

WITNESSETH: WHEREAS, Allen Bergstrand has performed services for Carbon County and both he and the County wish to formalize that relationship by contract; and

WHEREAS, the nature of the services performed by Mr. Bergstrand are to coordinate local agencies for response to any emergency situation and the nature of that work is not subject to the continuing control and supervision of the work and therefore lends itself to the status of Mr. Bergstrand being an independent contractor;

NOW, THEREFORE, in consideration of the premises and in the mutual covenants and agreements contained herein, it is mutually agreed as follows:

1. Allen Bergstrand agrees to perform services for Carbon County, Wyoming as an independent contractor to coordinate local agencies for response to any emergency situation. He shall be considered as an independent contractor and the County shall not withhold any retirement, Social Security, or other personnel benefits available to County employees.

2. In exchange for the professional services rendered by Allen Bergstrand, Carbon County agrees to pay Allen Bergstrand the sum of \$330.00 per month.

3. This agreement shall continue indefinitely, but shall be subject to termination by either party upon fifteen (15) days written notice.
