COMPUTER BUDGET SCHOOL

A motion was made by McMahon and seconded by Lemich and unanimously carried to allow Marilyn Bradford to attend the NCR Computer School in Denver, Colorado March 10th, 11th and 12th and March 17th, 18th, 19th and 20th.

COUNTY AGENT

The County Agent's Office was admonished by the Commissioners for signing two purchase contracts instead of Lease contracts. A unanimous agreement was made to take \$10,000.00 from the Agent's budget for the upcoming year to cover the costs for these two vehicles.

CARBON COUNTY PLANNING & ZONING

Discussion was made by Lance Stewart and Bob Gibson on a proposal for comprehensive planning for a proposed recreational district and the county fairgrounds. The matter was taken under advisement.

Case #79-35 - Zone Change - Daniel McCartney, P.O. Box 1392, Saratoga, Wyoming - zone change from RAM (Ranching, Agriculture & Mining) to RD-40 (Residential Development) on 40 acres located approximately 1/2 mile NW of Saratoga, Site is legally described as NW $\frac{1}{4}$ NE $\frac{1}{4}$ Section 10, T17N, R84W, Carbon County, Wyoming. A motion was made by Lemich and seconded by McMahon to approve. Roll was called with the following results; Grieve-aye, Lemich-aye, McMahon-aye.

Case #79-36 - Zone Change - George Kingsolver, P.O. Box 217, Colstrip, Montana - zone change from RAM (Ranching, Agriculture & Mining) to RD-20 (Residential Development) on 40 acres to allow for 2 single family dwellings each on 20 acres. Site is located approximately 2 miles NE of Saratoga and is legally described as NW $\frac{1}{4}$ SE $\frac{1}{4}$ Section 31, T18N, R83W, Carbon County, Wyoming. A motion was made by Lemich and seconded by McMahon to approve. Roll was called with the following results; Lemich-aye, Grieve-aye, McMahon-aye.

June Alysworth and Jean Lambertson presented a bid to the Commissioners for erecting an addition to the Museum Building to house the old fire engine given to the Board for the museum. A motion was made by Lemich and seconded by McMahon to approve the construction with the conditions they receive another bid for the building and to take the lowest bid. SALARY RESOLUTION

A motion was made by Lemich and seconded by McMahon to approve the following Resolution:

R E S O L U T I O N

WHEREAS, the Board of County Commissioners of Carbon County are lawfully assembled in a regular meeting of said Board in the Courthouse Building, Rawlins, Wyoming; and WHEREAS the statutes of the State of Wyoming provide that the Board of County Commissioners shall set the salaries for the County Assessor, County and Prosecuting Attorney, County Clerk, Clerk of the District Court, County Sheriff, County Treasurer and Justices of the Peace, which salaries shall not be changed during the term of each official for whom a salary is determined; and

WHEREAS there has been some ambiguity in the salaries for the various elected officials during the present terms of office, but such salaries cannot be changed during this term of office, but it is the intention of the Board to clarify any ambiguities for the next term of office for the respective positions;

NOW, THEREFORE, BE IT RESOLVED that the County Assessor, County and Prosecuting Attorney, County Clerk, Clerk of the District Court, County Sheriff, and County Treasurer of Carbon County, Wyoming, shall receive an annual salary commencing January 1, 1983 in the amount of Twenty-five Thousand Dollars (\$25,000.00) and that each of said officers pay any retirement and medical benefit contributions personally.

BE IT FURTHER RESOLVED that Justices of the Peace in Carbon County, Wyoming, who are duly qualified as attorneys and admitted to the Wyoming State Bar Association as required by law shall receive the sum of Fifteen Thousand Dollars (\$15,000.00) annual salary commencing the first day of any term beginning after the date of this resolution and that the said Justices of the Peace shall pay any retirement or medical benefit contributions personally.

HANNA RECLAMATION

The Commissioners unanimously agreed with RAMP (Rural Abandoned Mines Program) presented to them by Bob Yeager, Soil Conservationist from Medicine Bow, Wyoming and Carol McGuire, Administrator for the Town of Hanna. The program is designated for a controlled type reclamation of property that the County owns and lands that the Town owns.

MOUNTAIN BELL

The Board approved the placing of a telephone plant on Carbon County Road Right of Way No. 22536, Job No. W-0-5009, Line No. RL 10-A, Buried in Section 25, Township 18N, Range 84W, Saratoga, Wyoming.

CARBON COUNTY FAIR BOARD

Bert Johnson was reappointed to the Carbon County Fair Board for a five (5) year term commencing February 1, 1980 to February 1, 1985.

CARBON COUNTY MUSEUM BOARD

Charlotte Vivion was appointed to the Carbon County Museum Board to fill the unexpired term of Cecil Johnson for the term of August 6, 1978 to August 6, 1981.

MOUNTAIN BELL

A letter of intent to Mountain Bell to maintain and provide a Dimension 400 System for the Carbon County government was approved by the Board.

COUNTY DEED

MOUNTAIN VIEW ESTATES ACCESS ROAD

The Board of County Commissioners applied to the Commissioner of Public Lands for a right of way for a county road 60 feet in width across the following described lands:
