FHA LEASE

SENIOR SERVICES BOARD

A motion was made by McMahon and seconded by Grieve to re-appoint Sally Bocott, Saratoga to a three year term commencing March 1, 1981 and ending March 1, 1984. Nordahl Kirkeeng, Rawlins, was appointed to a three year term commencing March 1, 1981, and ending March 1, 1984.

The Commissioners formally expressed their appreciation to Marian Patchen for her three years of service on the Board.

SALE OF COUNTY PROPERTY

Bids were opened for the sale and removal of the house located at 220 West Pine. Grieve made a motion which was seconded by McMahon to take the bids under advisement. Roll was called with the following results: Grieve, Aye; McMahon, Aye.

STATE HIGHWAY DEPARTMENT

A motion was made by McMahon and seconded by Grieve to accept the contract presented by the State Highway Department on a State County-County Farm to Market Road Program. Roll was called with the following results: McMahon, Aye; Grieve, Aye.

PROJECT AGREEMENT - STATE COUNTY-COUNTY FARM TO MARKET ROAD PROGRAM

SC-CFM 6-28

THIS AGREEMENT made and entered into on this 17th day of March, 1981, by and between the Wyoming State Highway Department, hereinafter referred to as the DEPARTMENT and the Carbon Board of County Commissioners, hereinafter referred to as the BOARD.

WHEREAS, the Board desires to take advantage of the provisions of Sections 219 (SOS), 144 (Bridge), 203 (Railway Crossings), Title 23 United States Code and Sections 24-2-110, 24-4-101 (SC-CFM), 24-5-101 (IR), Wyoming Statutes by cooperating with the DEPARTMENT in a local road project.

NOW THEREFORE, the parties hereto agree as follows:

1. The proposed project will involve P.E. and construction consisting of (1) gravel widening and plant mix overlay on the Rawlins So. Co. Rd. #401, Beg. at end of SHS, S for 5.8 mi. and (2) isolated minor reconstruction, widening, culvert extensions and gravel surfacing for approx. 8.2 mi. If funds are not available for the entire project at time of letting, it is the desire of the County Commissioners to split the project accordingly.
2. The DEPARTMENT will prepare plans, specifications, and final cost estimates, and will award a construction contract to the lowest qualified bidder. Final design, plans and cost estimates will be concurred in by the Board prior to advertising. All construction work will be under the control of the DEPARTMENT in accordance with the project plans and specifications.
3. The estimated project cost is approximately \$631,000.00 to be funded as follows:

SC-CFM Funds (93%)	\$586,830
County Matching (7%)	44,170
	<u>\$631,000</u>

The BOARD will reimburse the DEPARTMENT for its participating share within thirty (30) days after being billed by the DEPARTMENT.

Should the BOARD abandon the project prior to advertising for bids, the BOARD shall reimburse the DEPARTMENT for all expenses of surveys and preparing project plans and documents.

5. Acquisition of right-of-way and utility adjustments required for the project will be the responsibility of the BOARD. The BOARD agrees to follow the policies set forth in the Wyoming Relocation Assistance Act of 1973, Section 9-729 through 9-750 in the acquisition of right-of-way required for the project to be constructed under this agreement.

6. The BOARD shall maintain the project at its own expense after the project has been accepted by the DEPARTMENT. Maintenance shall include all repairs necessary to keep the improvements at its original standard, as constructed.
