CARBON BUILDING

The following Change Order was presented for approval:

L.M. Olson, Inc., Bid Package No. 10, Carpentry Work.

A motion was made by McMahon which was seconded by Grieve and unanimously carried, to approve the change order as presented.

FUEL CONSERVATION CONCEPTS

Steve Sencabaugh, Vice President of Fuel Conservation Concepts, Inc., made a presentation on the Triactor process of conserving energy. The Commissioners asked that he review the heating system in the Courthouse and the heating/cooling system in the Carbon Bldg. and return with a proposal. The matter will be taken under further consideration at that time.

CITY OF RAWLINS

A motion was made by McMahon and seconded by Grieve to sign the lease with the City of

Rawlins for space in the Carbon Building. The motion was unanimously carried.

LANDSCAPING OF THE CARBON BUILDING

Lance Stewart presented a plan for the landscaping of the Carbon Building. A motion was made by McMaohn and seconded by Grieve to call for bids for the landscaping with the right of rejection. The bids will be considered at the May 5th meeting. The motion was unanimously carried.

CARBON BUILDING

Marv Kesler presented several releases on Contractors from the Department of Revenue. The final phases of work on the Carbon Building were reviewed.

MEMORIAL HOSPITAL

Randall Draney requested four or five rooms of space set aside for Hospital/Doctor use in the Carbon Building be designated as temporary office space for a portion of the Hospital's bookkeeping staff. The area will be allowed by the Commissioners, with the approval of the Hospital Board.

MEDICINE BOW SENIOR CENTER

It was moved and seconded and unanimously carried to negotiate with School District #2 on the purchase of the Home Economics Building in Medicine Bow, to be used for a Senior Center. A letter of proposal will be sent to School District #2.

REMODELING OF DATA PROCESSING

A motion was made by Grieve and seconded by McMahon to approve the bid of Arrow Construction for remodeling of the Data Processing Room. Roll was called with the following results: Grieve, Aye; McMahon, Aye.

There being no further business, the meeting was adjourned.
