A motion was made by McMahon and seconded by Grieve to accept the bid of Big "R" Manufacturing & Distributing, Inc. for bridge lumber and the bid from Culverts & Industrial Supply Co. for culverts. *RDP*

COUNTY HEALTH INSURANCE POLICY

Renewal of the county Health Insurance Policy with Equitable Life Association of the U.S. was approved by the Commissioners for the policy year beginning September 1, 1981.

CARBON COUNTY SENIOR SERVICES

The Commissioners approved the Senior Services budget for meals for the fiscal year beginning October 1, 1981 and ending September 30, 1982, in the amount of \$357,361.72, the County participation being \$54,943.20.

MOUNTAIN BELL

The Board approved placing of a telephone plant on County Road Right-of-Way No. 25821 (Revised), Line No. RL7-F-7, Section 25, 30, Township 19N, Range 78W, Rock River, Wyoming.

CITIES SERVICE GAS COMPANY

A Permit for ingress or egress, Permit No. 48, was given to Cities Service Gas Co., located on Carbon County Road 701, Section 15, Township 17N, Range 93W, Carbon County, Wyoming. *701*

There being no further business, the meeting was adjourned until the following day.

SEPTEMBER 2, 1981

The Board resumed its session at 10:00 A.M. Commissioners Martin McMahon and Robert Grieve were present. Commissioner Emil Lemich was absent.

COUNTY INSURANCE ON BUILDINGS & VEHICLES

Henry Hewitt reviewed the insurance coverage on the county buildings and vehicles. He suggested that the building coverage be increased 10% because of higher replacement costs. The Commissioners will take this under advisement.

PUBLIC HEALTH NURSE

A motion was made by McMahon and seconded by Grieve and unanimously carried to enter into a continuing agreement with the State of Wyoming, Department of Health & Social Services, Division of Health & Medical Services to maintain WIC Program Services for residents of Carbon County from October through June, 1982.

PEDRO MOUNTAIN RANCH ESTATES

Owners of the Pedro Mountain Ranch Estates north of Hanna, together with members of Carbon County Planning & Development and the County Attorney, met with the Commissioners for a preliminary discussion regarding the impact that rezoning several tracts of land north of Hanna from Ranching & Agriculture to an R.D. classification would have on this area. The population density under R.D. - 10 could be 800 residences, R.D. - 20, 400 residences or under R.D. - 40, 200 residences. Also under discussion was access to and within the area, fire protection, law enforcement, sewer, water and snow removal.

Pedro Mountain Ranch Estates will make application for zoning changes at the October meeting of the Planning & Development Board.
