AIR CONDITIONING UNITS IN COURTHOUSE

A motion was made by Lemich, seconded by Grieve and unanimously carried to authorize the modification of the air conditioning system in the Data Processing area. Figures will also be obtained and discussed at a later date regarding modification of the system in the District Court Room.

MEMORIAL HOSPITAL

A motion was made by McMahon, seconded by Lemich, and unanimously carried to accept the proposal from L.M. Olson Co. on the driveway excavation for the West driveway at Memorial Hospital, in the amount of \$2,240.00.

SHERIFF VEHICLE

A motion was made by Lemich, seconded by McMahon, and unanimously carried to allow Glenn Ashmore Chev. an additional \$675.00 for payment on a 1977 vehicle which was inadvertently listed as a 1978 vehicle when the bids were accepted.

COUNTY ROADS #203 and #660

The following Report of Viewer was filed:

REPORT OF VIEWER

COMES NOW Robert Grieve, the duly appointed Viewer for the proposed vacation and creation of the county roads described herein in Paragraphs A and B, and hereby recommends the vacation of the county road on the legal description set forth in Paragraph A hereinabove and the creation of the roads set forth in Paragraph B hereof for the reason that said vacation of the road and creation of the roads merely is being done to accomplish the legal creation of roads where they physically exist and the legal vacation of the road where it does not physically exist and this can be done without cost to the County by a trade of the land vacated by the County to the John E. Rouse Trust in exchange for a perpetual easement where the county road is actually physically located.

COOPERATIVE AGREEMENT AMENDMENT

The following is an amendment to the Plan of cooperation entered into between the Child Support Enforcement Section, Wyoming State Division of Public Assistance and Social Services and the Carbon County Attorney (Law Enforcement Agency), on 7/1/81 through 6/30/82, in respect to Sections V and VI (previously incorrectly numbered VII).

PAYMENT FOR SERVICES

Payment for services will be made quarterly at the rate of \$30.00 per hour, but as otherwise specified in Section V.

EFFECTIVE DATE

This agreement as amended shall be effective as of July 1, 1981 and shall expire on June 30, 1982, but as otherwise specified in Section VI (previously incorrectly numbered VII).
