HANNA-CARBON COUNTY JOINT POWERS BOARD

A motion was made by Lemich, seconded by McMahon, and unanimously carried to re-appoint Jim Haigler to the Hanna-Carbon County Joint Powers Board for a period of three years beginning November 8, 1981 and ending November 8, 1984.

JEFFREY CENTER BOARD

A motion was made by Lemich, seconded by McMahon, and unanimously carried to re-appoint Delores R. Loudon to the Jeffrey Center Board for a period of five years, beginning December 4, 1981 and ending December 4, 1986.

CARBON COUNTY PLANNING & DEVELOPMENT BOARD

A motion was made by McMahon, seconded by Lemich, and unanimously carried to re-appoint Harry Russell, III to the Carbon County Planning & Development Board for a period of five years, beginning December 4, 1981 and ending December 4, 1986.

Lemich made a motion to nominate J.A. Zwierzycki to fill the unexpired term of B.G. Michie on the Planning & Development Board. The motion was seconded by McMahon. There were no further nominations. Roll was called to approve J.A. Zwierzycki to fill the unexpired term, beginning December 15, 1981 and ending December 4, 1982, with the following results: McMahon, aye; Grieve, aye; Lemich, aye.

WYOMING STATE LEGISLATURE APPOINTMENT

A vacancy in the House of Representatives was declared due to the resignation of Representative B.G. "Jerry" Michie, effective November 31, 1981. The Carbon County Democratic Central Committee did, on the 12th day of December, 1981, meet to elect the following individuals for deliberation by the Carbon County Commissioners in the selection of a Representative to fill the vacancy:

A motion was made by Lemich to adopt the following Resolution:

RESOLUTION 1981-11

WHEREAS, B.G. Michie has resigned his post as a State Representative from Carbon County in the Wyoming State Legislature effective the 30th day of November, 1981, and;

WHEREAS, the Carbon County Board of Commissioners deems it necessary and advisable to appoint a replacement for Mr. Michie to serve out the remainder of his term, that is, to serve out the term which ends on the first Monday in January, 1983; and;

WHEREAS the Carbon County Board of Commissioners has called upon the Democratic Central Committee for Carbon County to submit three nominations to it for consideration; and

WHEREAS said Committee did gather for this purpose on Saturday, December 12, 1981, and did submit three nominations to the Board for its considerations; and

WHEREAS the Board has received those nominations and considered them;

BE IT THEN RESOLVED that William M. McIntosh be appointed, effective this date, to replace B.G. Michie as the Democratic State Representative from Carbon County in the Wyoming State Legislature to fill out the remainder of Mr. Michie's term.

The motion was seconded by McMahon. Roll was called with the following results: McMahon, aye; Grieve, aye; Lemich, aye.

JUSTICE OF THE PEACE

A motion was made by Lemich and seconded by McMahon and unanimously carried to accept the resignation of David E. Erickson from the position of Justice of the Peace, effective December 31, 1981.

Mr. Erickson was appointed by the Governor to serve as an Assistant Carbon County Public Defender.

A motion was made by Lemich, seconded by McMahon and unanimously carried to adopt the following Resolution:

RESOLUTION - 1981-12

WHEREAS, pursuant to Section 5-4-207, Wyoming Statutes, 1977, the Supreme Court of Wyoming is vested with supervisory powers over Justice Courts of the State of Wyoming, and

WHEREAS, pursuant to that power the Supreme Court of the State of Wyoming has designated qualifications for Justices of the Peace and procedures for their appointment; and

WHEREAS, pursuant to a Resolution adopted January 3, 1979, two Justices of the Peace positions have been created for Rawlins, Wyoming, and David E. Erickson has resigned from one of the said positions effective the 31st day of December, 1981,

NOW, THEREFORE, be it resolved that the Board of County Commissioners of Carbon County will accept written applications for the vacant position of Justice of the Peace in Rawlins, Wyoming, until 4:00 P.M., January 4th, 1982. Such applications shall be in the form of a letter addressed to the Board of County Commissioners and it shall be filed with the Office of the County Clerk, Courthouse Building, Rawlins, Wyoming.

The qualifications for the Justice of the Peace applicants shall be as follows:

- A. Must reside within the City of Rawlins, provided that if the Board of County Commissioners finds extraordinary circumstances to exist which warrant an exception to the residence requirement it may present its findings, including an assurance that the Justice will be available as provided in Paragraph D, and appropriate request to the Supreme Court that an Order be granted allowing such exception.
- B. Must be a qualified elector of Carbon County.
- C. Must be of good moral character and have a good reputation in the Community.
- D. Must be available and willing to perform the duties of a Justice at all times of the day or night.
- E. Must agree to attend, and attend, the first available training school after election or appointment and each training school thereafter while in office, or be subject to disciplinary action.
- F. Must agree to comply with all constitutional provisions, statutes, rules and regulations pertaining to the office of Justice of the Peace, and to submit such reports and data as required by the Supreme Court.

CARBON COUNTY ROAD & BRIDGE

Approval was given to Frank Smith to purchase guard railing, blocks, reflectors and a clipper saw to build and repair county bridges and cattle guards.
