AMENDMENT NUMBER ONE OPERATING AND FINANCIAL PLAN SHERIFF, CARBON COUNTY, WYOMING

This amendment, made and agreed to this 22nd day of March, 1982, becomes part of the Operating and Financial Plan signed by the Forest Service and Sheriff, Carbon County, Wyoming, on June 20, 1981.

Under paragraph B.2:

1. First sentence: Delete "but not to exceed a total of \$5800.00 for the period established for this plan."
2. Change first sentence: Add "but not to exceed a total of \$5100.00 for the period established for this plan."

Under Paragraph B.2: "Rate Schedule for Reimbursable Services", change last two sentences to read "It is estimated that the total expenditure for services listed in items A, 1, 2 and 6 above will be approximately \$5100.00 per year. This shall include approximately \$4800.00 for items A1 and A2 and \$300.00 for items A6 described above.
