CARBON COUNTY COUNSELING CENTER

Robert R. Knappenberger, Executive Director, and the Board of Directors of the Carbon County Counseling Center presented the program report of the Center's activities showing the increase in client contacts over the past three years. The Counseling Board also presented a budget request for \$49,500.00 for 1982-1983.

COUNTY COURT

McMahon made a motion which was seconded by Lemich to adopt the following Resolution:

RESOLUTION 1982-3

WHEREAS, the Board of County Commissioners of Carbon County, Wyoming are lawfully assembled in a regular meeting of said Board in the Courthouse Building, Rawlins, Wyoming; and

WHEREAS, Section 5-5-103(a), Wyoming Statutes 1977, as amended, permits counties in the State of Wyoming which have a population of less than 30,000 to establish county courts by the adoption of a Resolution establishing the same; and

WHEREAS, the Board of County Commissioners has previously adopted a position that Carbon County, Wyoming, should implement a county court system effective January 1, 1983, if the Wyoming State Legislature adequately funds the same; and

WHEREAS, in the judgment of the said Board of County Commissioners, the Legislature has in fact adequately funded county courts for Carbon County, Wyoming, and the Commissioners therefore wish to implement such program; and

WHEREAS, the Board of County Commissioners wish to reserve the right to withdraw from the county court system for any reason at the conclusion of a four-year trial period;

NOW, THEREFORE, BE IT RESOLVED That there is hereby created in Carbon County, Wyoming the county court system as said system is embodied in Chapter 5 of Title V of the Wyoming Statutes, 1977, as amended, effective January 1, 1983.

BE IT FURTHER RESOLVED, that effective January 1, 1983, or as soon thereafter as the terms of the Justices of the Peace expire, the office of Justice of the Peace in Carbon County, be and the same are hereby abolished until further action of the Board of Commissioners of Carbon County, Wyoming.

BE IT FURTHER RESOLVED, that the Board of County Commissioners reserve the right to terminate the county court system in Carbon County, Wyoming for any reason, effective January 1, 1987.

BE IT FURTHER RESOLVED, that the County Court Judges and staff maintain the records heretofore kept by the Justice Court of Carbon County, Wyoming.

SALARY RESOLUTION

McMahon made a motion which was seconded by Lemich to adopt the following Resolution:

RESOLUTION 1982-4

WHEREAS, the Board of County Commissioners of Carbon County, Wyoming, are lawfully assembled in a regular meeting of said Board in the Courthouse Building, Rawlins, Wyoming; and

WHEREAS, Section 18-3-107, Wyoming Statutes, 1977, provides that the Board of County Commissioners of each County in the State of Wyoming shall meet not later than June first of the year preceding any election for County Assessor, County Prosecuting Attorney, County Clerk, Clerk of the District Court, County Sheriff and County Treasurer; and

WHEREAS, said Section 18-3-107, Wyoming Statutes, 1977, also provides that each County Commissioner will be paid such compensation as the Board of County Commissioners determine by Resolution, and that said Board shall meet not later than June 1, 1982, for the purpose of setting their salaries for the following four years, commencing January 1, 1983; and

WHEREAS, the Board of County Commissioners has duly deliberated and discussed the various factors which are determinative of said salaries; and

WHEREAS, the Board has determined that the County Assessor, County Clerk, Clerk of the District Court, and County Treasurer shall receive an annual salary for the calendar year 1983 in the amount of \$30,000.00, and an annual salary for the calendar year 1984 of \$32,000.00, and an annual salary of \$34,000.00 for the calendar year 1985, and an annual salary of \$36,000.00 for the calendar year 1986, together with the same benefits as accorded other County employees; and

WHEREAS, the Board has determined that the County and Prosecuting Attorney and the County Sheriff shall receive an annual salary of \$32,000.00 for the calendar year 1983, \$34,000.00 for the calendar year 1984, \$36,000.00 for the calendar year 1985, and \$38,000.00 for the calendar year 1986, together with the same benefits as other County employees receive; and

WHEREAS, the Board of County Commissioners has further determined that each County Commissioner shall be paid an annual salary in an amount of \$7,200.00 in each of the calendar years of 1983 through 1986; and

WHEREAS, the Board of County Commissioners has further determined that it is appropriate for the Clerk of the District Court to deposit funds received by said officers from the State Workmen's Compensation Fund received for services rendered to said Fund which are a part of the duties of said office and for which County salaries are paid to the general fund of Carbon County, Wyoming;

NOW, THEREFORE, BE IT RESOLVED that the County Assessor, County Clerk, Clerk of the District Court, and the County Treasurer of Carbon County, Wyoming, shall receive an annual salary of \$30,000.00 for the calendar year 1983, \$32,000.00 for the calendar year 1984, \$34,000.00 for the calendar year 1985, and \$36,000.00 for the calendar year 1986. In addition to said monetary compensation, the said elected officers of Carbon County, Wyoming, shall receive the same benefits as accorded other employees of Carbon County, Wyoming, at the date of the adoption of this Resolution, including but not limited to the same retirement matching contributions from the County as other County employees, and the same coverage under any County insurance policies at the rates accorded other County employees.

BE IT FURTHER RESOLVED, that the County and Prosecuting Attorney and the County Sheriff of Carbon County, Wyoming, shall receive an annual salary of \$32,000.00 for the calendar year 1983, \$34,000.00 for the calendar year 1984, \$36,000.00 for the calendar year 1985, and \$38,000.00 for the calendar year 1986. In addition to said monetary compensation, the said elected officers of Carbon County, Wyoming, shall receive the same benefits as accorded other employees of Carbon County, Wyoming, at the date of the adoption of this Resolution, including but not limited to the same retirement matching contributions from the County as other County employees, and the same coverage under any County insurance policies at the rates accorded other County employees.

BE IT FURTHER RESOLVED, that each of the County Commissioners, with an effective term commencing January 1, 1983, shall be compensated in the amount of \$7,200.00 annually. In addition to said monetary compensation, the said elected officers of Carbon County, Wyoming, shall receive the same benefits as accorded other employees of Carbon County, Wyoming, at the date of the adoption of this Resolution, including but not limited to the same retirement matching contributions from the County as other County employees, and the same coverage under any County insurance policies at the rates accorded other County employees.

BE IT FURTHER RESOLVED, that the Clerk of the District Court, Carbon County, Wyoming, deposit any funds received by that officer from the State of Wyoming for services rendered to the Workmen's Compensation Fund to the general fund of Carbon County, Wyoming.

BE IT FURTHER RESOLVED, that the salaries herein established shall not be changed during the four-year term of said elective officers.

BE IT FURTHER RESOLVED, that any and all prior Resolutions previously adopted that are in conflict herewith, specifically including the Resolution adopted February 6, 1980, be, and the same are hereby repealed.

WYOMING HIGHWAY DEPARTMENT

The following agreement was approved:

REVISED PROJECT AGREEMENT
 State County-County Farm to Market Road Program
 SC-CFM 6-28
 (Project)

THIS AGREEMENT, made and entered into on this 18th day of May, 1982, by and between the Wyoming State Highway Department, hereinafter referred to as the DEPARTMENT and the Carbon Board of County Commissioners, hereinafter referred to as the BOARD.

WHEREAS, the Board desires to take advantage of the provisions of Sections 219 (SOS), 144 (Bridge), 203 (Railway Crossings), Title 23 United States Code and Sections 24-2-110, 24-4-101 (SC-CFM), 24-5-101 (IR), Wyoming Statutes by cooperating with the DEPARTMENT in local road project.

NOW, THEREFORE, the parties hereto agree as follows:

1. The proposed project will involve P.E. and construction on the Rawlins South County Road #401

including (1) spot improvement to extend 66" RCP, minor grading and erosion control at a point 1.2 miles south of the end of the SHS #71. (2) Beginning approximately 5.8 miles south of the SHS and extending southerly 8.2 miles, grading, draining, gravel surfacing, misc. work and gravel stockpile.

2. The DEPARTMENT will prepare plans, specifications, and final cost estimates, and will award a construction contract to the lowest qualified bidder. Final design, plans and cost estimates will be concurred in by the Board prior to advertising. All construction work will be under the control of the DEPARTMENT in accordance with the project plans and specifications.

3. The estimated project cost is approximately \$900,000.00 to be funded as follows:

SC-CFM Funds	(93%)	\$837,000.00
County Matching	(7%)	<u>63,000.00</u>
		\$900,000.00

The Board will reimburse the DEPARTMENT for its participating share within thirty (30) days after being billed by the Department.

4. Should the Board abandon the project prior to advertising for bids, the Board shall reimburse the DEPARTMENT for the expenses of surveys and preparing project plans and documents.

5. Acquisition of right-of-way and utility adjustments required for the project will be the responsibility of the Board. The Board agrees to follow the policies set forth in the Wyoming Relocation Assistance Act of 1973, Sections 9-729 through 9-750 in the acquisition of right of way required for the project to be constructed under this Agreement.

6. The Board shall maintain the project at its own expense after the project has been accepted by the DEPARTMENT. Maintenance shall include all repairs necessary to keep the improvement at its original standard, as constructed.

2. Change first sentence: Add "but not to exceed total of \$5100.00 for the period established for this plan."

Under paragraph B.2: "Rate Schedule for Reimbursable Services", change last two sentences to read "It is estimated that the total expenditure for services listed in items A, 1, 2 and 6 above will be approximately \$5100.00 per year. This shall include approximately \$4800.00 for items A1 and A2 and \$300.00 for item A6 described above.
