The following Agreement was signed:

A G R E E M E N T

THIS AGREEMENT, made and entered into by and between the University of Wyoming, hereinafter referred to as the University, and the Board of County Commissioners of Carbon County, hereinafter referred to as the County.

WITNESSETH: That whereas, it is desired by the County to employ, under the Federal Smith Lever Act and the State Acceptance Act of 1915 and amendments thereto covering Extension Work in Agriculture and Home Economics, a University Extension Agent for the purpose of assisting and encouraging the general development of agriculture, home economics, 4-H and community development throughout Carbon County, and that said work shall be done and directed under the supervision of the Associate Director of the Agricultural Extension Service of the University of Wyoming:

CAMPAIGN REPORTING REQUIREMENTS, 22-25-106, W.S. 1977 - All candidates whether successful or not must file a statement of campaign receipts and expenditures by September 24, 1982

FILING OFFICES, 22-25-107, W.S. 1977 - Candidates for municipal, county, judicial, school or college board offices file with the County Clerk. Candidates for state legislative or district judgeship offices file with the County Clerk and Secretary of State. Candidates for statewide offices file with the Secretary of State.

A candidate who fails to file a full and complete itemized statement within the time required is guilty of a misdemeanor and no such candidate shall receive a certificate of nomination or election, nor shall he enter upon the duties of the office, and a vacancy shall exist. 22-25-108, W.S. 1977.
