CARBON COUNTY HOSPITAL BOARD

A motion was made by Lemich, seconded by McMahon and unanimously carried to accept the resignation of Edward Ziolkowski from the Hospital Board, effective July 6, 1982.

A motion was made by McMahon, seconded by Lemich and unanimously carried to re-appoint Robert Pappenheim for the unexpired term of Ed Ziolkowski being July 6, 1982 to July 6, 1983.

A motion was made by Lemich, seconded by McMahon and unanimously carried to appoint Christian F. Cronberg for a five year term from July 6, 1982 to July 6, 1987.

CARBON COUNTY SENIOR CENTER BOARD

A motion was made by Lemich, seconded by McMahon and unanimously carried to appoint Josephine Salisbury to the Senior Services Board to represent Dixon. Her term will commence July 6, 1982 and end March 4, 1985.

CARBON COUNTY LIBRARY BOARD

A motion was made by McMahon, seconded by Lemich and unanimously carried to appoint Judith A. Sheehan, Baggs, and Clyde T. Chatman, Sinclair, to the Library Board for three year terms beginning July 1, 1982 to July 1, 1985. The appointments were made to fill the expired terms of Virginia Briggs and Darrell Stewart.

CARBON COUNTY MUSEUM BOARD

A motion was made by Lemich, seconded by McMahon and unanimously carried to re-appoint Jean Lambertson to the Museum Board for a three year term, beginning July 1, 1982 to July 1, 1985.

911 COOPERATIVE AGREEMENT

THIS COOPERATIVE AGREEMENT, made and entered into on the 6th day of July, 1982, by and between the City of Rawlins, the Town of Sinclair, the Town of Wamsutter, the Town of Bairoil, the County of Carbon, the Memorial Hospital of Carbon County and the Wyoming Highway Patrol.

WITNESSETH:

WHEREAS, the City of Rawlins, Town of Sinclair, the Town of Wamsutter, the Town of Bairoil, the County of Carbon, the Memorial Hospital of Carbon County and the Wyoming Highway Patrol have signed Letters of Intent requesting the City of Rawlins to interface with Mountain Bell to install and provide a Basic 911 System for all areas covered by Mountain Bell's prefix 324 and 328; and

WHEREAS, the municipal governmental and public service agencies which will be receiving 911 calls desire to reduce their understandings relative to the Basic 911 System to writing,

NOW, THEREFORE, for and in consideration of the mutual covenants, promises and conditions contained herein, the parties agree as follows:

1. Interfacing Agency: The City of Rawlins will order from Mountain Bell a Basic 911 System and is hereby authorized as the single entity to interface with Mountain Bell to provide a Basic 911 System to all areas covered by Mountain Bell's prefix 324 and 328. The City of Rawlins agrees to provide a dispatch center for the Basic 911 System, which center will be assigned the priority task of receiving and dispatching the 911 telephone calls.

2. Direct Line Agencies: The Carbon County Sheriff's Office, the Rawlins Fire Department and the Memorial Hospital of Carbon County will have direct lines from the dispatch center to their agency in order to allow prompt, efficient and error free bridging from the 911 center. The cost of the direct line from the 911 dispatch center to the direct line agency will be borne by the direct line agency and will be paid directly to Mountain Bell.

3. Dispatching Cost: The City of Rawlins agrees to utilize its present twenty-four (24) hour dispatch service, and the City further agrees to assign 911 telephone calls the priority in dispatching duties. However, when the amount of time required to answer, handle and dispatch the 911 calls requires additional staffing, all parties to this Agreement agree to share on a utilization ratio basis the cost of additional staffing. The parties to this Agreement shall pay their share of the additional staffing costs to the City of Rawlins on a quarterly basis. The City of Rawlins reserves the right to discontinue the priority dispatching basis for 911. In the event that the City, in its discretion, chooses to no longer assign 911 a priority, then and in that event the City will consult the County and other 911 users and they shall together determine the appropriate staffing for 911.

4. Method of Dispatching Calls: The City of Rawlins shall dispatch 911 calls in the following manners:

(a). Carbon County Sheriff's Office: All calls which require the service of the Carbon County Sheriff's Office shall be bridged to number 324-2776. The Carbon County Sheriff's Office agrees to provide a twenty-four (24) hour dispatch service so that all calls dispatched by the 911 dispatch center will be answered at the 324-2776 number.

(b) Memorial Hospital of Carbon County: All calls requiring the services of the Memorial Hospital of Carbon County will be dispatched to a direct line number. The Memorial Hospital of Carbon County will provide a twenty-four (24) hour dispatch service such that all calls bridged from the 911 center to the direct line number will be answered by the Memorial Hospital of Carbon County.

(c) Rawlins Fire Department: All calls requiring the services of the Rawlins Fire Department shall be bridged to a direct line number. The Rawlins Fire Department will provide a twenty-four (24) hour dispatch service such that all calls bridged from the 911 center to the direct line number will be answered by the Rawlins Fire Department.

(d) Town of Sinclair: All calls requiring police services of the Town of Sinclair shall be bridged to the Carbon County Sheriff's Office. Fire calls for Sinclair will be dispatched to fire reporting number 324-2000.

(e) Wyoming Highway Patrol: All calls requiring the services of the Wyoming Highway Patrol shall be bridged to the Carbon County Sheriff's Office, who will then dispatch to the Wyoming Highway Patrol.

(f) Town of Wamsutter: All calls requiring the services of the Town of Wamsutter shall be bridged to _____. The Town of Wamsutter will provide a twenty-four (24) hour dispatch service such that all calls bridged from the 911 center to phone number _____ will be answered by the Town of Wamsutter.

(g) Town of Bairoil: All calls requiring the services of the Town of Bairoil shall be bridged to a command conference number of 328-0279.

(h) Sweetwater County Sheriff's Office: All calls requiring the services of the Sweetwater County Sheriff's Office shall be bridged to the Carbon County Sheriff's Office in accordance with paragraph 4 (a).

CARBON COUNTY ROAD & BRIDGE

G. Frank Smith, Road Supervisor, and Sam Verplancke, Maintenance Supervisor, presented their monthly reports to the Commissioners.

TXO AGREEMENT

A motion was made by Lemich, seconded by McMahon and unanimously carried to approve the following Agreement:

Re: Paulson State #1, Section 32-T19N-R81N, Carbon County, Wyoming

Pursuant to the agreement reached during a meeting with you on 5 January, 1982 and to my letter of 29 March, 1982, both regarding snow closure of and damages to a portion of the Pass Creek Road, TXO Production Corp., (hereinafter referred to as "TXO") will provide for County use at our expense an independent contractor's equipment as follows: Three (3) 20-cubic yard dump trucks and drivers for four (4) nine-hour days. The purpose of this equipment is to assist the Carbon County Road and Bridge Department with gravel capping operations on portions of the Pass Creek Road. It is understood that Carbon County will provide gravel material, a front-end loader and operator, and grader(s) to facilitate efficient gravel hauling along the Pass Creek Road and that the gravel hauling will be coordinated through the Carbon County Road and Bridge Department and supervised by the Carbon County Engineer.

TXO's assistance with gravel hauling on the Pass Creek Road is furnished as full compensation for any damages to Carbon County or its property caused by our snow removal and/or other operations in the vicinity of Elk Mountain during the drilling of the referenced well this past winter. Acceptance of the heavy equipment assistance, attested by executing this letter agreement, shall constitute a full and complete release of all damages or claims that Carbon County has against TXO in regard to drilling or related operations on the Paulson State #1 well.

If you, as legal representatives of Carbon County, agree to the provisions set forth in this letter, please


