CARBON COUNTY CHILD DEVELOPMENT

A motion was made by McMahon, seconded by Lemich and unanimously carried to approve the bid from Rocky Mountain Mobile Home, Rawlins, to move a modular building donated by School District No. 1 to a site near the Child Development Center in South Side. The motion was made contingent upon the approval of the bid by the County Attorney. The bid includes moving, repairs, and remodeling for the specific amount of \$20,200.00.

MEDICINE BOW CLINIC

The final plans for the Medicine Bow clinic were presented to the Commissioners for approval.
