#### CARBON COUNTY ROAD #401

Members of the Wyoming Highway Department met with the Commissioners and the Road & Bridge Supervisor to determine the extent of construction by contract on Road #401. The consensus was to widen and gravel Road #401 from the end of the State section to Sage Creek if project cost estimate does not exceed available Farm-to-market funding.

#### SENIOR CITIZENS BOARD

Following an executive session with members of the Senior Citizens Board, a motion was made by Lemich, seconded by McMahon and unanimously carried to write a letter to Lyla Payton to support the decision made by the Senior Citizen's Board concerning a personnel matter regarding the Senior Services program in Encampment.

#### CARBON COUNTY PUBLIC HEALTH NURSE

A motion was made by Lemich, seconded by McMahon and unanimously carried to execute a contract by and between Carbon County and the Northwest Colorado Visiting Nurses Association, a non-profit association incorporated in Colorado, for the purpose of furnishing public health and home health nursing services in conformance with the State of Wyoming Standards for an area of Wyoming, surrounding and including the communities of Baggs, Dixon and Savery. These services will be provided an average of two and one half days a week during this contract.

There being no further business, the meeting was adjourned.
