#### ROCK CREEK FIRE DEPARTMENT

#### CARBON COUNTY SENIOR SERVICES, INC.

Maureen Johns, Administrator and Nordahl Kirkeeng, Board Member presented a Revised copy of the Carbon County Senior Services, Inc. Personnel Guidelines for the Commissioners to review. Changes were suggested with regards to hearing procedures. A new draft of policies will be made and reviewed by the County Attorney.

#### CARBON COUNTY PLANNING & DEVELOPMENT

Public Hearing was held before the Board of Commissioners on the following:

A motion was made by Lemich, seconded by York to table case No. 83-02. Roll was called with the following results: Grieve, Aye; Lemich, Aye; York, Aye.

Case No. 83-03 - Zone Change - A.L. Parmely, 1241 Elk St., Casper, WY 82601, Zone Change from RAM (Ranching, Agriculture, Mining) to RD-40 (Residential Development) to allow for the development of two single-family recreation residence on an 80 acre parcel. Site located in the Canyon Creek area of northern Carbon County and legally described as the NE $\frac{1}{4}$ , S $\frac{1}{2}$ , SW $\frac{1}{4}$  Section 6, Township 28 North, Range 83 West, Carbon County, WY.

A motion was made by Lemich, seconded by York to approve Case No. 83-03. Roll was called with the following results: Grieve, Aye; Lemich, Aye; York, Aye.

Case No. 83-04 - Zone Change - Bill Rasberry, P. O. Box 930, Saratoga, WY 82331, zone change from RAM (Ranching, Agriculture, Mining) to RD-5 (Residential Development) to allow for the development of four single-family residences in the proposed Arapaho Flats subdivision. The site is located east of Riverside, WY, and is legally described as the E $\frac{1}{4}$ , NW $\frac{1}{4}$ , NW $\frac{1}{4}$  Section 5, Township 14 North, Range 83 West, Carbon County, WY.

A motion was made by York, seconded by Lemich to approve Case No. 83-04 contingent upon the final approval of the Arapaho Flats Subdivision Plat. Roll was called with the following results: Grieve, Aye; Lemich, Aye; York, Aye.

Case No. 83-06 - Zone Change - Rory McFarland, P. O. Box 4253, Boulder, CO 80306, zone change from RAM (Ranching, Agriculture, Mining) to RD-40 (Residential Development) on a 60 acre parcel of land legally described as a parcel in Section 11 and 14, Township 14 North, Range 86 West, Carbon County, WY. and on a 160 acre parcel of land legally described as a parcel in Section 22, Township 14 North, Range 87 West, Carbon County, WY.

A motion was made by York, seconded by Lemich to approve Case No. 83-06. Roll was called with the following results: Grieve, Aye; Lemich, Aye; York, Aye.

Bess Sheller appeared before the board to discuss budget items in the new fiscal year budget.


#### BUREAU OF LAND MANAGEMENT
