UNDERGROUND AND UTILITY PERMIT

Your request for permission to install a 8" pipe line along or across County Highway No. 121 at Sta. 17+56 - Sec. 2, T22N, R79R is granted when properly signed below by the Carbon County Engineer or his authorized agent.

This work shall be completed within two (2) days from the starting date. No work shall be allowed on Saturdays or Sundays.

IT IS UNDERSTOOD that the Permittee will cause installation at no expense whatsoever to Carbon County and the Permittee will own and maintain the same after installation..

The 8" Natural Gas line shall be installed beneath the surface of the right-of-way at a minimum cover of 36 inches and the disturbed portion of the right-of-way shall be restored to its original condition. All backfilling shall be in eightinch lifts and mechanically compacted to 95% of Standard Proctor.

All road crossings shall be bored. Said installation shall be encased in pipe of larger diameter when required and the crossing shall be as nearly perpendicular to the roadway as physically possible. No water shall be used in the boring and no tunneling shall be permitted.

Where the installation crosses any ditch, canal or water carrying structures, the applicant must obtain permission from the owner or owners, and perform installation in accordance with specifications as provided by said owner or owners.

A copy of permission and specifications shall become a part of this permit.

This work must be accomplished in accordance with accepted good practices and conform to the recommendations of the National Electric Safety Code and to such statutes as are applicable.

Construction warning signs, conforming to the Uniform Traffic Control Device Manual and to the Supplement, shall be in place daily prior to starting any work. If proper signs are not in place during any work, the County Engineer or his authorized agent shall immediately stop all work until proper signs are in place.

Traffic shall be maintained on all roads at all times. Flagmen shall be provided at any locations where the orderly flow of traffic is interrupted.

The Permittee shall maintain the installation at all times and agree to hold Carbon County, Wyoming, the agencies thereof, and their officers and employees harmless from any and all loss and damage or any claims which may rise out of or be connected with the installation, maintenance, alteration, removal or presence of the installation herein referred to or any work or facility connected herewith, within the area covered by this permit.

If it becomes necessary to change the location of the proposed line, written approval must be secured from the County Engineer.

Permittee will be required to shut off lines and remove all combustible materials from the County right-of-way when requested to do so by Carbon County, Wyoming, because of necessary highway construction or maintenance operations.

Permittee shall mark this installations with markers acceptable to Carbon County, Wyoming, a minimum of two signs per mile, and shall be marked by two signs at each bridge or ditch crossing, and at each road crossing.

In the event any changes are made to this roadway in the future that would necessitate removal for relocation of this installation, Permittee will do so promptly at its own expense upon written request from Carbon County, Wyoming. Carbon County, Wyoming, will not be responsible for any damage that may result in the maintenance of the highway or to the installation placed inside County right-of-way limits.

A RESOLUTION DESIGNATING THE CARBON COUNTY CHILD PROTECTION TEAM AS THE JUVENILE PLANNING COMMITTEE OF CARBON COUNTY, WYOMING, TO PREPARE A PLAN FOR A YOUTH SERVICES PROJECT FOR CARBON COUNTY, WYOMING, PURSUANT TO WYOMING SENATE FILE 87, ENROLLED ACT. NO. 46.

WHEREAS, Carbon County, Wyoming hereby establishes a Juvenile Planning Committee to prepare a problem definition and a plan for a youth services project to conform with the intent of Enrolled Act. No. 46, Forty-Seventh Legislature of the State of Wyoming, and

WHEREAS, by law the Juvenile Planning Commission must be composed of at a minimum the following: Division of Public Assistance and Social Services representative, Probation and Parole representative, Mental Health representative, Law Enforcement representative, Public Schools representative, and a representative of a private non-profit agency that works with juveniles, and

WHEREAS, said entities are already represented on the Child Protection Team of Carbon County, Wyoming, and

WHEREAS, the functions of the Child Protection Team of Carbon County are consistent with the functions of the Juvenile Planning Committee,

NOW, THEREFORE, the County Commissioners of Carbon County, Wyoming, hereby designate the Carbon County Child Protection Team as the Juvenile Planning Committee of Carbon County, the County Commissioners shall instruct them as to the objectives of the proposed plan, and the State of Wyoming will provide technical assistance to the Juvenile Planning Committee through its planning process.

A draft of a Flood Plain Management Resolution was presented to the Board for discussion. A new draft with proposed changes will be presented at a later date.


CARBON COUNTY ECONOMIC DEVELOPMENT CORP.
